## KSO-GHQ DETAILED ALARMING SERIES OF EVENTS HAPPENING AT MOREH, SENAM

The Kuki Students' Organisation General Headquarters (KSO-GHQ) vehemently condemned the shocking and inhumane incidents that unfolded in Moreh and Senam Village, Tengnoupal District recently, where state forces were reportedly involved in acts of violence, looting, destruction, and torture against innocent civilians, including women and children.

It said that those actions were not only appalling but also a grave violation of human rights and the principles of justice.

In a statement issued on Thursday, KSO said: "A series of alarming actions in Moreh including looting of houses, destruction of properties, seizure of important documents and torturing of innocent civilians by the state forces have serious ramifications against the peace and tranquility set-up in the border town. The terror act perpetrated by the State Forces against the innocent civilians have caused untold miseries resulting in severe financial and emotional distress to the affected families, loss of properties and livelihoods for the resident. The seizure of documents such as ID Cards and documents further endangered the rights and security of the residents. Shockingly, children and women were not spared from the brutality, with reports of physical and psychological torture emerged at this point."

The terrible actions of the state forces at Moreh and Senam village are deeply troubling and represent a violation of the basic principles of safety, security, and respect for the rights of individuals and communities. The affected victims and their families deserve justice and support during this challenging time. The incident demands a thorough and impartial investigation to identify those responsible and bring them to account for their actions, it added.

The KSO-GHQ strongly condemned those actions and called for immediate and transparent investigations into the matter to identify and hold accountable to those responsible for such heinous acts. "We demand that justice be served to the victims and their families," KSO urged.

The KSO-GHQ also strongly condemned the recent actions of MP Leishemba Sanajaoba for



his alleged instigation of violence through social media. His public statement, where he openly called for an attack on Moreh, is not only irresponsible but also dangerous and unacceptable. We call on the appropriate authorities to investigate this matter thoroughly and take appropriate actions in accordance with the law, KSO said, adding that promoting hate speech and inciting violence through any means, including social media, should not go unpunished.

The KSO-GHQ also strongly condemned the looting of arms and ammunition from the 1st MR and 2nd MR at Imphal. The use of these weapons to carry out attacks on areas like Moreh and Senam is not only a threat to the safety and security of the affected communities but also a severe violation of human rights.

The illicit use of stolen weaponry in acts of violence endangers the lives and well-being of innocent civilians, disrupts peace and stability in the region, and undermines the principles of justice and human rights. We categorically reject such actions, as they have far-reaching and detrimental consequences for the people and communities in the area, it said.

The KSO urged upon all relevant authorities to take immediate and effective measures to apprehend those responsible for the looting and to prevent further misuse of these weapons. The protection of human rights, the rule of law, and the safety of the affected communities should be paramount in addressing this issue.

## KSO'S 48-HR SHUTDOWN CALL ENFORCED STRICTLY IN LAMKA, KANGGUI



The first day of the 48 hours total shutdown called by the Kuki Students' Organisation, General Headquarters (KSO-GHQ), has brought all normal activities to a grinding halt in Lamka town, Churachandpur district. The shutdown was called in protest against the continued deployment of the occupational State forces in Moreh, a Kuki-Zo inhabited border hill-town along Indo-Myanmar boundary.

Since morning, supporters came out in large numbers to enforce the shutdown at various junctions of different localities and main road, inter-connecting with other districts. Shops and establishments located within the localities were closed.

The streets and market places wore a deserted look as there was hardly any movement of vehicles except for security personnel, medical personnel and other essential services. Educational institutions and government offices remained closed. There was no report of any untoward incident during the shutdown.

Meanwhile, the Kuki Students' Organisation has announced for a mass rally along with total shutdown to be carried out on November 3, 2023.

Following the imposition of total shutdown for 48-hours in all Kuki-Zo dominated areas in Manipur by top Kuki-Zo tribal bodies, a public protest was also held at different locations in Kuki-Zo dominated Kangpokpi district against the forceful occupation of Moreh by the Meitei.

institutions, in Kangpokpi district remained closed while the important National Highway-2 wore a deserted look as vehicles stayed off the road except those exempted from the purview of the total shutdown imposed by KSO-General Headquarters and Committee on Tribal Unity Sadar Hills Kangpokpi.

Volunteers were seen enforcing the total shutdown and blocking the highway at various places.

The public protest organized by CoTU was held at Kangpokpi District Headquarters, Saparmeina and Gamgiphai where thousands of people mostly womenfolk took part in the protest at the three locations.

The public protest was held under the same banner, "Protest against the forceful occupation of Moreh by Meiteis" in the three locations while shouting similar slogans, "Save Moreh from N. Biren Singh", "Save Kangpokpi from N. Biren Singh", "Save Churachandpur from N. Biren Singh", "Save Kuki-Zo from Meitei insurgents", "Remove Meitei militants from Moreh", "We want political solution", "We want Separate Administration", etc.

The protestors also held placards that read, "We want immediate withdrawal of partisan forces", "The ill-design of N. Biren Singh costs innocent lives", "Meitei insurgents are incorporated in the state forces", "Six months of unrest, where is peace?", "Double Engine or Humanity?", etc.

## LOOTING OF ARMS CONTINUES IN IMPHAL; 3 CENTRAL SECURITY PERSONNEL INJURED

Even as the ethnic violence in Manipur between the majority Meitei and minority Kuki-Zo continues for about half a year, fresh looting of arms and weapons still occurred in the capital city, Imphal.

As per reliable source, on November 1 at around 6:00 PM, suspected Meitei radicalised groups numbering about 700 stormed the 1st Bn. Manipur Rifle campus through the North Gate No.1 in SUVs mounted with sophisticated weapons with an intent to snatch arms and ammunition from DGP Pool Arm Kote and Unit Pool Arm Kote (Quarter Guard), 1MR.

The 1st Battalion of Manipur Rifles is located at just about 500 metres away from the high security zone of chief minister's bungalow, Bapupara, Imphal.

The Security forces fired tear gas and live rounds and repelled the armed miscreants at around 7:45 PM. Gunfiring between the armed miscreants and security personnel ensued for about two hours.

It was reported that 03 personnel of K/152 Battalion CRPF deployed at North Gate, 1st Bn. MR sustained injuries in the scuffle when the armed miscreants tried to snatch their service weapons. The injured personnel were identified as Arup Das (39 yrs) S/o Umesh Chandra Das of Dhupguri District, Assam, bullet injury in the right side shoulder; Nalijit Taluk Das (27) S/o Romani Talukdar of Assam, minor head injury, and Lil Kantha Raj (29) S/o Pradeep Raj of Assam, minor injury on left finger.

The armed miscreants took away arms and ammunition such as two tear gas guns and one AK-47 along with three magazines containing 88 ammunitions from the personnel deployed in and around 1st Bn. MR campus.

The escort personnel of IGP (Zone-I) were also robbed and one KT43 (AK rifle) bearing No. 7586 along with three Magazines and 90 number of rounds; one KP43 (AK rifle) bearing No. 6795 along with two Magazines and 60 number of rounds; KP43 (AK rifle) bearing No. 6915 along with three Magazines and 90 number of rounds; two numbers of AK Rifles Magazines and 60 numbers of rounds; two numbers of tear gas guns (i.e 2K16 bearing No. 23158 and 2K15 bearing No. 20964), and six numbers of Bullet Proof caps and BP plate set of 4 numbers were taken away.

From the armed security of Manipur, Central Jail located at Old Lambulane, one AKM Ghatak bearing Regd. No.203900298 along with two Magazines and 60 number of rounds; one AKM bearing Regd. No. BA44-7094 along with three Magazine and 90 number of rounds; one INSAS Rifles bearing Regd. No. 16841366 along with three Magazines and 60 numbers of rounds, and two SLR Magazines along with 40 number of rounds were taken away.

Further, the armed radicals also destroyed IGP prisons office, Superintendent of Jail office, JCO room and took away five vehicles such as: One Bolero and one hard top Gypsy for IGP prisons, two numbers of Gypsy along with one walkie talkie set attached to the vehicle of Superintendent Manipur Central Jail Imphal, one Gypsy assigned to QRT, one hard top Gypsy assigned to senior FO and one Gypsy assigned to escort of SP Sajiwa.

The armed group also entered and ransacked the computer room of Manipur Police Control Room, NAB office and office of ADGP(Int), Manipur. They also fired at the office of CID (SB) and took away another one Gypsy bearing No. MN01W0311 which was parked under locked and key at the main gate of Sanamahi Temple, 1st MR which was allocated to W. Ishwarchandra Singh, DY.CO-5th IRB.

In this regard a case has been registered at Imphal PS, police said.

**TLM Views:** Though various arms and ammunitions have been looted from DGP Pool Arm Kote and Unit Pool Arm Kote (Quarter Guard), 1MR, the looting of arms failed to find space in the Meitei news media outlet. Even the authority concerned – the Home Department, which is headed by the Chief Minister himself, has no single Press briefing in this regard till now. This raised serious doubts about the sincerity of the concerned department and the bias Imphal based media outlets. Are the Meitei media and the state government colluding with the Meitei radicalized groups to conceal their sinister design of looting government armories as most of the looted weapons are usually used for waging war against the Kuki-Zo people?

# STATE SPECIAL FORCES IN MOREH HAVE BECOME TERRORISTS? WOMEN, CHILDREN FORCED TO FLEE



A reign of terrors unleashed by the occupational Meitei forces on the innocent civilians of Moreh, a Kuki-Zo inhabited border town, has caused a distressing turn as the residents, mostly women and children, were compelled to leave their homes and sought refuge in the camps of Central security forces.

The consequence of the presence of the Meitei police commandos is the Kuki-Zos had to flee their homes.

The combing operation carried out by the security forces in the aftermath of the killing of one Meitei police officer seemed to have become another excuse to loot and plunder household properties, and to commit atrocities to the innocent civilians of the border hill-town. Women were not spared, they were harrassed and tortured by the Meitei police commandos.

It was said that the Meitei Police commandos have vandalized several houses, vehicles, washing machines, TVs, and other household properties. They have also robbed money, gold necklaces and other jewelleryes. In Govajang, the wife of the chief was beaten; blankets were also taken away with a warning that they would come again. The Police Commandos have also pointed their loaded guns at the women and tortured them.

The atrocities on the Kuki-Zo civilians resulted in the injury of three women including a minor - Hoijaneng Touthang (46y) W/o Ngamlun Kipgen, Nenghoithem kipgen (15) D/o Seithang kipgen, and Tinneichong Kipgen (33) W/o Seithang Kipgen.

### Questions thus arise:

1. Are State police forces formed or recruited to torture innocent civilians, rob money, steal gold necklaces, and damage civilian properties? Aren't they employed to maintain law and order?
2. Why are the Assam Rifles - Sentinels of the North East, giving the State commandos a free hand and turning a deaf ear and a blind eye to the suffering of innocent civilians?
3. Has Manipur Police become terrorists, robbers, and plunderers?

The atrocities and havoc done to the people of Moreh requires immediate intervention by the centre government; if not, the volatile situation in the border town and surrounding areas could escalate and the end result will be the sole responsibility of the Centre and State governments.

## VIRAL VIDEO: RADICALIZED MEITEI MAN BURNS DOWN EDUCATIONAL DOCUMENTS OF TRIBAL

In a viral video surfacing on various social media platforms, a Meitei man burnt the educational certificates and other important documents of one tribal by the name Lentinlal Mate of Kholim Village, near Sugnu Tribal, Chandel district. The documents of Lentinlal Mate was said to have been seized by the Meitei radicalized groups when arsoning of tribal villages in the surrounding of Sugnu area happened in the month of May, after the villagers reportedly fled their home when they were under serious attacks by the radical groups and Manipur Police Commandos.

In the video, the man who seems to be in inebriated condition challenged the Kukis, saying as “As you guys are no longer part of Manipur, all your documents issued by the Manipur government and the concerned educational board have to be burnt down.”

On further investigation, the man in the viral video is said to be an employee of Indigo Airline who works as Ground Staff at Kempegowda International Airport in Bengaluru.

TLM Views: The viral video is just one among the many attacks on Intellectual property of an individual belonging to Kuki-Zo community. During the initial stage of the ethnic violence, many students have faced the same fate wherein all their educational certificates and essential documents were burnt to ashes inside the Manipur University premises.

## ARMED STAND-OFF: MEITEI RADICALISED GROUPS CHALLENGE AR

A video went viral on social media platforms wherein the armed combatants of the infamous Arambai Tenggol faced off with troops of Assam Rifles at Sanjenthong Bridge near the CM's bungalow in Imphal on Thursday 2nd November 2023.

The voice of one Arambai Tenggol member can be heard saying “The Assam rifles are waiting at the CM's, We are all ready here and now and we'll see who wins, Casper (BP Vehicle) or not, we've finished one round of gunfight for now”. A background voice can also be heard calling for Light Machine Gun (LMG) to the vicinity.

In stark contrast to the recent claim of CM N Biren Singh where he said that 90 percent of the state has been in “peace”, there has been reports of hundreds of radical Meitei youths attempting to take control of state forces' armories in 1st and 2nd Manipur Rifles compound in Imphal the previous day. As is evident in the viral video today and weeks prior, the state's radicalized youths have openly flaunted their looted weapons, faced off the central forces in open area without



any fear of reprimandation. This could only be possible as the Meitei radical youths are openly patronized by the Chief Minister and the Titular King Sanajaoba.

However, all these threats and intimidating messages openly aimed at Central forces never invited any legal action from the concerned authority. The case could however be different if all those were shared by a certain community – FIRs??



## TOP LEADER OF MANIPUR STATE, CABINET MINISTERS DELIBERATELY MISSED KUT GREETINGS

The Chief Minister of Manipur, N. Biren Singh has deliberately missed a traditional Kut Greeting to the people of Chin-Kuki-Mizo on the auspicious occasion Kut Festival 2023 on November 1, a state holiday.

Greetings on the Chavang Kut festival poured in from Her Excellency the Governor of Manipur Anusuiya Uikey, the Chief Minister of Nagaland Neiphiu Rio, the All India Congress Committee, M Kharge, amongst others. However, greetings from the chief minister and his cabinet colleagues find no mention in the list.

The ongoing ethnic cleansing pogrom of Manipur CM N Biren Singh with the unconditional support from the majority community has rather rendered the Kut day to be void of any celebrations as it usually was in the past years. The day itself has seen communal Meitei police commandos conducting combing operations in the hill town of Moreh over the alleged claim of an SDPO ranked police officer killed a day prior by armed miscreants in Moreh town.

There has been no visual of the so-called "People's CM" of Manipur N Biren's greetings over the same unlike the previous years where he usually attended the celebrations as the chief guest and made speeches of unity, brotherhood and the likes. N Biren, apropos to the office he holds, is expected to convey his greetings and wishes to the community befitting his position as the CM of the state, his personal emotion and leanings towards a certain community is consequential on this matter. His silence amidst the ongoing crisis speaks volume about his stand as the CM of the state. It may be inferred that "the People's CM" here is the "Meitei People's CM", and that the office of the CM has intentionally ignored a particular section of the state population which only points to the fact that the Office of the Chief Minister is futile to the Chin-Kuki-Mizo community.

It can also be inferred that the state CM has failed to differentiate his personal feelings and professional duties thereby diluting the sanctity of the office he holds. The office and the official nonetheless had lost its credibility when the CM openly sided with a certain community instead of trying and finding ways to quell the violence in its initial days, and

## WHO REALLY IS CHINGTHAM ANAND SINGH?

*“Mr Anand’s colleagues remembered him as a pleasant, cheerful police officer who maintained a good rapport with locals in the border town, where there is a constant pressure of illegal immigrants and refugees fleeing Myanmar’s junta, insurgents, looters and drug traffickers” –NDTV.*

### But who really is Mr. Chingtham Anand Singh?

On the 2nd day of April 2010, a National newspaper THE TELEGRAPH reported the then CM Okram Ibobi’s promise to a magisterial inquiry over the suicide of a young girl, Khumukcham Shyamashakhi Devi, 24, a resident of Kakching Khunou in Thoubal District after she consumed sulphuric acid, a day after she was allegedly raped. The rapist was none other than the “respected” police officer Chingtham Anand Singh, then an inspector of the infamous Manipur Police Commando. The young girl was working at a private clinic in Mayang Imphal, Imphal West. Anand Singh was posted at Mayang Imphal police station, close to the clinic, and used to visit it frequently. The mother of the young girl was quoted saying “The inspector raped my daughter at gunpoint and threatened her with death if she disclosed it to anyone. She disclosed about the rape before she committed suicide”. An FIR was registered at Waikhong Police Station after Manimacha Devi, the mother of the girl, lodged a complaint. However the culprit was never arrested and walked free till the time of his demise 23 years later in 2023. A joint action committee, formed by the residents of Kakching Khunou, submitted a memorandum to the then chief minister wherein they alleged that the inspector had raped Shyamashakhi at gunpoint and threatened to kill her, her family members and her boyfriend if she told anyone about the rape. It also charged that the inspector took her signature on a sheet of blank paper after the rape. It claimed that Shyamashakhi had made these disclosures to her mother and friends before her death.

In another unsurprising event, kanglaonline, a news portal on October 2 2016 reported a case on its portal about a certain ‘Officer in Charge’ (OC) of Thoubal Police Commando wherein the OC allegedly thrashed a police constable at Yairipok Phoudel on the night of September 28, 2016. The OC in question is again none other than Chingtham Anand Singh. The victim in the said case was identified as one Thokchom Romen, 33, of Sagoltongba Mamang Leikai, a rifleman of 1st IRB then attached to Thoubal police commando. The victim’s wife Thokchom Nganthoi said that her husband was thrashed while on



duty at Yairipok Phoudel waiting shed along with three other constables and an ASI. “The OC was in an inebriated condition when he thrashed Romen”, Nganthoi said. The victim was admitted to RIMS the next day, with worsening condition was then shifted to Raj Medicity. A complaint was lodged to the DGP and the SP of Thoubal police. But the culprit, like in the above mentioned case, was never apprehended until the time of his death in 2023.

The above two cases are a few examples of many instances where the recently deceased officer made his name. One can now conclude that Late Chingtham Anand Singh was not someone with a good reputation during his long service career as claimed by the majority Meiteis but rather a rapist and perpetrator of crimes against humanity. Before he was allegedly shot dead by unknown miscreants, he was also remembered by many as one arrogant police officer devoid of humanity.

Mention may be made that the Meitei insurgent groups-UNLF and others, are strictly against rape culture in the society and whoever committed such crimes were given death penalty. It was suspected that Anand Singh might have evaded the clutch of these insurgent groups, courtesy of his high position in Manipur Police.

**MANIPUR GOVT'S PRO-MEITEI MEASURES ARE STIMULANTS FOR SEPARATE ADMINISTRATION DEMAND**

The demand for separate administration by the Kuki-Zo people is assuming more significance in the light of the partiality shown every now and then by the Government of Manipur. Such prejudices are evident again in the aftermath of the Moreh incident wherein a Meitei police officer was killed by unidentified gunmen. The antecedent of this police officer namely Chingtham Anand showed that he is involved in a rape case after which the victim committed suicide. The Biren Singh-led government called an emergency cabinet meeting the same day and announced certain benefits for the deceased police officer. Rs. 50 lakh as ex-gratia and a government job to the next of kin was announced. Contrary to this measure, the government maintained a stoic silence to the killing of Kuki police officer who also met his fate while on duty. In the eyes of the Manipur government, Kukis are children of a lesser god and their lives do not matter as much as the Meiteis' do. This is a fact nobody can deny.

Another case that merits serious pondering is how CSOs from the valley and the hills are treated. The Manipur Cabinet in its meeting on 31st October approved to recommend for declaration of the World Kuki-Zo Intellectual Council (WKZIC), as an unlawful association/organization under section 3 of the Unlawful Activities (Prevention) Act, 1967. The decision was reached following a reported press release (although the WKZIC denied having issued the press release and said it was fabricated) on 24th Oct calling upon the Kuki-Zo community that during November, before the harvesting season, the community is likely to face another war; and urged the people to stock

arms and ammunition to face any eventuality. The Manipur cabinet related the WKZIC press release and the Moreh incident and thereby arrived at a decision to recommend the declaration of the WKZIC as an unlawful organisation.

In June this year, Meitei secessionist outfits' frontal organisation Coordinating Committee on Manipur Integrity (COCOMI) in its people's convention declared 'Manipuri National War against Chin-Kukis'. It also decided that the Meitei people should not give up arms till the total annihilation of the Chin-Kuki people from the soil of Manipur. It is not the time to recover/collect arms which were earlier handed over to the Meitei militias (and said to be looted), rather, the government should arm the Meiteis to achieve the objective of obliterating the Kukis. The Meitei-dominated Manipur government turned blind to this precarious step taken by the Meitei CSOs right under its nose. However, it now acted swiftly against the Kuki-Zo body whose call (even if it did so) was way lesser in tone and tenor than the Meitei CSO did in June.

Despite various Kuki bodies including the apex Kuki Inpi Manipur (KIM) highlighting the matter and its possible ramifications to the Government of India, nothing has been done yet.

All these partialities have happened because it is a Meitei-dominated government led by a bigoted Meitei radical. These injustices and selective amnesia have necessitated a political solution for the Kuki-Zo community by way of a separate administration.
