

COTU'S 48-HOUR TOTAL SHUTDOWN AGAINST SELECTIVE INJUSTICE AND SELECTIVE ENFORCEMENT OF LAW CRIPPLES NORMAL LIFE IN MANIPUR'S KANGGUI



The Committee on Tribal Unity (CoTU), Sadar Hills Kangpokpi's 48-hour total shutdown, which began this morning at 6:00 a.m. hit normal life hard in Manipur's Kangpokpi district with all normal activities coming to a standstill.

The CoTU's total shutdown will be enforced till 6:00 a.m. of November 13.

CoTU had announced the total shutdown considering the alleged objectionable events and keeping the sentiments of the public intact, with the sole demand of rationalizing the implementation of law and order for both the Meiteis and the Kuki-Zo.

Earlier, in the day the Kuki-Zo people as part of their mass movement held a massive rally at Kangpokpi District Headquarters and demonstration in front of the SP Kangpokpi office, where they demonstrated the whole night till this morning until the total shutdown began at 6:00 a.m.

Later, thousands of Kuki-Zo people mostly women across the district congregated at Kangpokpi town and Gamgiphai and strictly enforced the total shutdown.

All shops, business establishments, and educational institutions across the district remained closed while the vehicular movement came to a standstill along the National Highway-2.

Emergency services, press, and CoTU units which are exempted from the purview of the shutdown were only allowed to pass along the highway.

ills Strife-torn Manipur's Kangpokpi district has been back to a burning situation after the Kuki-Zo intensified their mass movement protesting the alleged 'Selective injustice and selective enforcement of the law' by N. Biren Singh's led Manipur Government as it intensified their demand for the release of the two Kuki-Zo individuals arrested by Manipur police.

CoTU's decision to impose a 48-hour total shutdown was taken in an emergency late Friday midnight meeting with all of its units/departments, and various civil society organizations at Kangpokpi District Headquarters following intense pressure from the public.

CoTU's Media Cell stated that the Kuki-Zo community is seriously disturbed by the selective injustice through discriminatory enforcement of law and order.

It alleged that the display of anarchy by terror groups such as Arambai Tenggol in the public sphere and the inaction of the state police in apprehending those outfits; the looting of church offerings in Kuki-Zo villages; the attempt to re-settle only the displaced Meiteis in Kuki-Zo areas; the biased security deployment for harvesting and the brutal killings of innocent Kuki-Zo civilians with the support of the state have affirmed that the law and order are apparently one-sided.

CoTU further stated that in case of negligence and inattention to our legitimate demands, the future course of action will be determined by the committee in consultation with the public.



THOUSANDS RALLY AGAINST 'EDUCATIONAL NEGLIGENCE' IN LAMKA



Thousands of students marched on the streets of and a culmination of their disorientation, a sign of Lamka (Churachandpur) on Saturday during a "Rally against educational negligence," protesting against the discrimination of Kuki-Zo students in Manipur, .

Students from various educational institute and Coaching Centers within the district congregated at Lamka Public Ground and marched till Mini Secretariat Complex, Tuibong, Churachandpur, raising various slogans against the government for the glaring educational disparity and the consequent negligence on the part of the state, where the conflict has rendered thousands of tribal students unable to resume their classes.

All forms of remedial measures in catering to Kuki-Zo students' interest are still pending, while months have passed since these students are left with no respite, Joint Students' Body (JSB), Lamka said in statement issued today.

"While students from all kinds of fields had their careers on hold, and at a time where job seekers have to travel to far off centers irrespective of the cost on their pockets, students of the Kuki- Zo ethnic tribes felt neglected at the slow pace of the state to adequately address their plight. The rally thus, is a demonstration of the students' frustration

protest against a partisan state which only promotes Meitei interests while neglecting the welfare and interests of the Kuki-Zo people and their students."

In light of the injustices borne by the Kuki-Zo students, the JSB submitted a memorandum to the Union Home Minister through the Deputy Commissioner which demanded the establishment of a Central University, institutes of technical and medical education, timely disbursal of funds and benefits under the tribal ministry to organizations based in the hill districts. The demand also included expediting the completion of Churachandpur Medical College (CMC) being undertaken at Mata Village and in the meantime, to streamline classes at the temporary centre at Headquarter Veng and immediate resumption of online examinations conducted by SSC/BANKS-IBPS/UGCNET/NEET-JEE/AGNIVEERS/ NTA etc at CDS-INFOTECH Lamka (Churachandpur).

"While we continue to support the efforts and demands of our leaders for a political solution, we resolve to continue our fight for justice - the other name for which is, 'Total Separation from Manipur,'" JSB reiterated in their memorandum addressed to the Union Home Minister.



ARAMBAI TENGGOL GOONS RUN THE SHOW IN IMPHAL VALLEY

The Imphal Valley has no longer a proper mechanism of Administration in place as the Arambai Tenggol goons run the show - killing, terrorizing people at will and reprimanding anyone speaking against them with severity.

The notorious Arambai Tenggols are roaming freely in Imphal valley, openly flaunting their looted weapons and the law enforcement agency seems muted for taking action against them.

As per the India Army and National Investigation Agency, re-imposition of AFSPA in valley districts of Manipur is an urgent need as the state and national security is under threat. But, the government of Manipur declared the Meiteis dominated districts as Non-Disturbed Area recently. Today, one can witness the Meitei terror groups branding with their looted sophisticated arms in full combat in front of the City Convention, Imphal, just about 300 metre away from the CM bungalow and State Police Headquarters.

The open declaration of war against the Kukis by the Arambai Tenggol's chief and inaction of the state government and the national agency is a clear manifestation of government involvement in the ongoing ethnic crisis. This terror group is an unofficial armed militia of the state top leadership including Leisemba Sanajaoba, Rajya Sabha MP and Meiteis' titular king. As such, they are given free hand without any intimidation by the security agencies. Imphal valley thus becomes a safe haven for these terror groups.



BIREN SINGH IN COMPLICIT WITH SOME RADICAL ELEMENTS: MLA PAOLENLAL

Manipur BJP MLA Paolienlal Haokip today said that his Chief Minister Biren Singh was "in complicity with some radical elements" and that Biren Singh "seems to allow those very few radical elements to wreak havoc".

Haokip has gone as far as demanding a change in leadership, his move being viewed as an open revolt against the chief minister.

"The chief minister should quit. If he does not, every legislator in his party has the moral responsibility to speak up against such kind of leadership that facilitates such human tragedy on the state," he told Northeast Live.

Asked if his stand did not amount to a revolt against the party he responded by saying that "the party did not have its manifesto that a radical section of society be nurtured



and let it cause this kind of havoc in the state".

He clarified that his was not a stand against the party but the chief minister.



CENTRAL SECURITY FORCES ARREST 23 MYANMAR-BASED MEITEI MILITANTS IN CHANDEL

Atleast 23 Meitei militants based in Myanmar general area of Aivomjang village Chandel District. were captured by the central security forces on Thursday after the militants tried to infiltrate into the Indian territory from Myanmar. PDF, ABSDF, CNDF, RCDF had been attacking

As per sources, the arrested Meitei militants were said to be active members from the banned People's Revolutionary Party of Kangleipak (PREPAK) and United National Liberation Front (UNLF) groups. Fourteen of the 23 captured militants belong to PREPAK while nine belongs to UNLF.

Sources said that the militants alongwith Myanmar Junta soldiers and family members escaped towards Indian border in New Samtal area of Manipur's Chandel district after the Democratic Alliance Army (DAA) overrun the Junta's camps in Khampat, Witotke, and Panthar (Pantha) in Tamu district Indian border alongwith the Meitei militants. Myanmar and tried to cross over Indian territory in

The Democratic Alliance Army including KIA, the camps of Myanmar Army and its militia group Pyu Saw Htee in Pantha - Kanan section of Asian Highway in Tamu district Myanmar since November 3. On November 7 at around 10:00 AM, the DAA overrun the Junta's camps and captured the stations of Junta soldiers and its militia groups in Khampat, Witotke, Panthar and others. It was also reported that 4 members of DAA got killed during the incident and several others sustained injuries while DAA captured 10 Junta soldiers alive.

Following the incident, many Junta soldiers fled for their lives while some of them fled towards the

PETITION FILED FOR DISMISSING FIVE JDU MLAS

Janata Dal United Manipur secretary general M Dorendro Singh has filed a petition in the High Court of Manipur seeking disqualification of five JD-U MLAs, who had joined the BJP in violation of the 10th Schedule of the Constitution of India as no action has been taken by Manipur Legislative Assembly speaker to an earlier petition filed in this regard.

The petition submitted by advocate Ajoy Pebam mentioned that Dorendro had filed a disqualification petition to the respondent, Manipur Legislative Assembly speaker, on January 11 but so far nothing has been done in this regard by the speaker.

Hence, the High Court of Manipur is urged to issue a directive to Manipur Legislative Assembly speaker for registering the case and conducting the trial.

The respondents in the petition filed on November 6 include Manipur Legislative Assembly speaker Thokchom Satyabrata, Thangmeiband MLA Kh Joykisan Singh, Tipaimukh MLA Ngursanglur Sanate, Jiribam MLA Md Ashab Uddin, Wangkhei MLA Thangjam Arunkumar and Churachandpur MLA LM Khaute.



The petition appealed to disqualify the five MLAs under 10th Schedule Article 191 (1) & Para 2 (1) and under Manipur Legislative Assembly Member Rule No.6 (Disqualification on the Ground of Defection) Rules, 1986.It also cited the order of Supreme Court of India passed on October 30 in connection with a writ petition, and contended that in the light of this Supreme Court order, five JDU MLAs who had announced merger with BJP on September 1, 2022 must be dismissed within two months.

The petition has been accepted by the High Court and set December 13 for the next hearing.









CAF & PD Minister L Susindro Meitei had said that 5,00,000 to 7,00,000 Burmese Kukis have intruded into Manipur and claimed that the ongoing violence in Manipur was instigated by the Kuki narco-terrorists coming from Myanmar, who had opposed the Manipur Government's drive against poppy plantations; thereby, preventing them from indulging in illicit drug businesses.

He made the statement during a programme held at from Myanmar, also entered Nagaland. a relief camp set up at the farmers' hostel of Veterinary and Animal Husbandry Services at Porompat on Solidifying his sheer hatred towards the Kukis like his November 8.

However, the statement itself is devoid of any facts and the Minister is simply making mere allegations without any substantial proof.

The fact of the matter is that according to the 1881 Census, the population of Kukis was 25,384, which accounted for 11.48 per cent of the state's population. In the 1951 Census, the Kuki population rose to 81,379, accounting for 14.06 per cent of the state population, and in 2011, the Kuki population was 4,48,214, which is 15.60 per cent of Manipur's population.

If one is to go by Susindro's statement, a bulk of the Kuki population is an intruder, which itself is devoid of any facts.

As per The Hindu news report dated July 25, 2023,

after a military coup in Myanmar in February 2021, there was an influx of refugees; over 40,000 refugees took shelter in Mizoram and around 2,000 are said to have entered Manipur.

The refugees belong to the Kuki-Chin-Zo ethnic groups who are closely related to the communities living in Mizoram and Manipur hill areas. Around 200 migrants, mostly Nagas from Myanmar, also entered Nagaland.

Solidifying his sheer hatred towards the Kukis like his mentor N. Biren, Susindro also stated that majority of the people living in the valley districts are unarmed and civilians but the reality is otherwise in Kuki dominated districts, said the Minister and claimed that almost all the Kuki families in hill districts possess guns either in the name of Suspension of Operation (SoO) agreement or for hunting purposes. However, the ground reality speaks otherwise. As per reports, gun licenses were issued with high records in valley districts under Biren Singh government than hill areas. Imphal valley is now flooded with arms and ammunitions looted from government armories. This is evident from many videos of Arambai Tenggol goons flaunting their sophisticated weapons in a full combat dress surfacing online in various media platforms.

The Minister said that he saw widespread poppy plantations in Kuki dominated areas. The fact is that poppy cultivation is widespread in hill areas irrespective of communities. It is good that recently, poppy fields were destroyed in Tora Champhung hill ranges in Ukhrul, a Naga dominated district.

Meanwhile, the Minister said that the Meeteis who have been living at Churachandpur didn't possess any land pattas and the same is very unfortunate. "I shed tears when I realise that Meeteis at Churachandpur have been living there so miserably,"

he said. However, the displaced Meiteis who are staying in Imphal from Churachandpur rebuked the Minister for his little knowledge on the matter. The statement made by Susindro also indicated his solidified position as a Meitei minister and not a minister for the whole community of Manipur.

The baseless assertions made by Susindro without any substantial proof only exposed Biren government's "proxy war" to annihilate one particular community. Susindro is one among the core members who supported and radicalised the Arambai Tenggol.



There is no movement towards peace in Manipur; Politically, Biren has lost credibility.

Lieutenant General Shokin Chauhan (Retd.)

Former Director General of Assam Rifles

"There are long histories of problems between the tribes in Manipur. They don't trust each other and are extremely wary.

"Usually, political changes are brought about by the youth, but presently Meitei and Kuki youth are at war with each other," says retired Lieutenant General Shokin Chauhan (retd), former director general of the Assam Rifles, the country's oldest and largest paramilitary force.

General Chauhan, a third generation army officer, was chairman of the Ceasefire Monitoring Group to ensure peace in the North East.

The officer has served for nearly 15 years in the North East over five different tenures. He has vast experience in conducting counter terrorist operations both in Kashmir and the North East, and served as the DG of the Assam Rifles for 16 months.

"Assam Rifles probably has the most difficult task among all Central Armed Police Forces and has discharged its duties excellently. It is the only organisation keeping the peace and has prevented mass scale genocide on both sides," says the distinguished military officer in the first part of a Zoom interview with Rediff.com's Archana Masih.

As an officer who has served long and important tenures in the North East, what are the historical reasons behind the inter-tribal clashes that have continued for six months in Manipur?

We need to know the background of Manipur to understand the present situation.

In the late 1700s Manipur was occupied by the Burmese empire and the king of Manipur sought the help of the British. The British and the Burmese fought three Anglo-Burma wars and by 1868 Burma became a part of the British empire.



After the British occupation, Manipur became a British protectorate resulting in many tribes migrating from northern and upper Burma towards Manipur for better prospects, land and water.

The Meitei king and the people had to learn to share the land with the migrants who arrived during the 17th, 18th, 19th and 20th centuries.

Post-Independence, Manipur came to be inhabited by three main tribes -- Meitei which are about 54%-55%, Nagas and Kukis, the latter were about 14% during Independence and maybe are 16%-17% presently. There has been no survey done [since 2011] to indicate the exact numbers.

What are the main issues and misgivings between the Meitei and Kukis?

Every flashpoint in the North East revolves around three main issues:

1. Land: Tribal land in the North East is in the hand of tribal societies. This is stated in Article 371, A, B, C, D of

the Constitution.

In Manipur, in accordance with these special provisions, the Nagas and Kukis own the land in the hills where they live. While the Meiteis own the land in the valley.

All the tribes in the North East are designated as scheduled tribes; however, the scheduled caste status was not given to the Meiteis. This could either be because they didn't want it in 1947-1948, or because they were better off than the rest of the people.

But over the last 20 odd years, the Meiteis feel that they have been cheated of the scheduled caste status which would in turn have helped in securing government jobs and also give them access to tribal lands.

2. Political power: The Meiteis are the most populous and dominant community. Except the brief period of Rishang Keishing who was a Tangkhul Naga, Meitei chief ministers have always headed the state government.

Since Kukis had the status of scheduled tribes, they got reservations in state jobs and as a result, moved up the ladder in the police and state administration. This also enabled Kukis to move from the hills towards the valley.

3. Cultural Identity: The Kukis came to Manipur only in the last three centuries, though they say that some Kukis fought for the Raja of Manipur in the 15th and 16th centuries, but the fact is that the majority of the Kukis came to the state in the last 300 years.

They have not been accepted in society because Meiteis feel that they have come in later and didn't deserve the land they made their own.

All issues in Manipur and the North East originate from land, cultural identity, and political power.

That is the root problem between the Meiteis and Kukis.

The Kukis had also settled in Ukhrul which is claimed by the Tangkhul Nagas. I was a young company commander posted there in the late 1980s. We were protecting the few Kuki villages because the Tangkhal Nagas had declared war on them.

What is different about the problem this time as compared to tribal feuds of the past?

What were the immediate triggers for the intra-

tribal clashes?

The immediate conflagration was on April 24 when the chief minister wanted to inaugurate an open gym in Churachandpur and there was disturbance in the valley.

Subsequently, on May 3-4, assailants set fire to the Anglo-Kuki memorial which is sacred and commemorates the Kukis who fought against the British before the First World War.

This incident added fuel to an already incensed crowd and created mayhem in the state.

The Meiteis feel that they are going to lose out on political power one day which is incorrect because they are 54%-55% of the population, but sometimes people are manipulated by politicians who make them insecure because that's the only way to get political support.

Secondly, like I said, as per the Constitution, those tribal lands are not available because the tribal societies own it and there was a push from the state government to declare certain areas as reserved forests that would have edged the Kukis out.

Why is there no resolution to the current problem that is seeing recurring violence over the past six months?

There are long histories of problems between the tribes. The different tribes and communities don't trust each other. They have been brought up on tales that have widened the divide and are extremely wary of each other. They live in separate areas.

Since the Meiteis are the dominant tribe, Kukis feel that they were being pushed out.

Why is there no end to this violence that has taken nearly 180 lives?

The violence can't end till the people from both societies get together and decide to end this violence.

Meitei and Kuki elders must sit together and say, let's end this violence. Usually, political changes are brought about by the youth, but presently Meitei and Kuki youth are at war with each other.

Unfortunately, I don't see any movement towards peace. Politically, the Biren Singh government has lost credibility amongst the Kukis and the Kukis are not going to listen to him.

The situation on the ground has to change to give peace a chance.

As former director general of the Assam Rifles, what are your thoughts about the challenges faced by the Assam Rifles in the last six months in Manipur?

Let me put it on record that the Assam Rifles is probably the best fighting force in the country today and equals any Indian army unit in its capability.

We have deployed the Assam Rifles extensively in Kashmir. They have also served in Sri Lanka and conducted successful operations against the LTTE in their areas of operations. They are an extremely experienced organisation.


The Assam Rifles has discharged its duties excellently and is the only organisation keeping the peace. It has prevented mass scale genocide on both sides and stopped many revenge operations.

The force is deployed in the North East, but it recruits personnel from different castes, communities from the entire country at the same percentages as the recruits of the Indian Army.
