

KUKI ORGANISATION WRITES TO SC-APPOINTED OFFICIAL DEMANDING PROBE AGAINST MANIPUR CM

A Kuki organisation has demanded registration of an FIR and investigation against Manipur Chief Minister N Biren Singh alleging conspiracy to commit "large scale ethnic violence" against the Kukis in the state.

The Kuki Organization for Human Rights Trust (KOHUR) has written in this regard to the Supreme Court-appointed officer monitoring probe in cases related to the ethnic violence in Manipur. In a memorandum addressed to Dattatray Padsalgikar, former Maharashtra Director General of Police appointed by Supreme Court to oversee the probe into Manipur ethnic violence cases, sent through Home Secretary Govind Mohan, KOHUR gave reference of news articles on a leaked audio purportedly of the Manipur minister and demanded action. The Manipur government has dismissed the recording as doctored.

The Kuki organisation also sought registration of an FIR and initiation of investigation against other unknown individuals for "conspiracy to commit large scale ethnic violence, including mass murder and sexual offences against the ethnic minority Kuki people residing within the state of Manipur, and for the commission of several overt and covert illegal and criminal actions in furtherance of the said criminal conspiracy". KOHUR also shared an approximately 48-minute long audio recording, purportedly of the Manipur chief minister.

"In an ethnically charged up environment, the remedy of approaching the regular police in Manipur by the undersigned, that too seeking police investigation against the sitting Chief Minister is an entirely illusory exercise. It may kindly be that noted your good offices was instituted by the Hon'ble Supreme Court specifically to remedy such a situation," the Kuki organisation said.



KOHUR also said if the attached audio recording is found to be false, doctored or manipulated in the course of the investigation under the present complaint, those found responsible for the making and propagation of such media ought to be prosecuted in accordance with law. Kuki groups have said the purported audio clip is evidence of the Manipur chief minister's involvement in the ethnic violence in the state. (Deccan Herald)









KUKI STUDENT'S TOP BODY APPEALS FOR REINSTATEMENT OF SSC EXAMINATION CENTERS IN CHURACHANDPUR AND UKHRUL

The Kuki Students' Organization (KSO) General Headquarters, an apex Kuki student body, has urgently appealed to the Chairman of the Staff Selection Commission (SSC), Shri Rakesh Ranjan, to reconsider the decision to cancel SSC CGL (Tier-1) examination centres in Churachandpur and Ukhrul.

In a letter addressed to the SSC Chairman, KSO expressed deep concern over the abrupt cancellation, which has caused significant inconvenience to numerous candidates from these regions who had been preparing for the examination. The decision has forced candidates to travel long distances to alternative centres, imposing logistical and financial hardships, especially given the poor road conditions from Churachandpur to Mizoram (Aizawl).

Moreover, KSO highlighted that due to the buffer zone between Imphal Valley and Churachandpur, minority Kuki candidates are unable to travel to Imphal for the examination, further complicating their situation. Despite full assurance from the Deputy Commissioner of Churachandpur regarding security measures, the centres remain cancelled.

KSO has called for urgent intervention by the SSC to review and reinstate the examination centres in Churachandpur and Ukhrul to ease the burden on aspirants and ensure a smooth examination process for all candidates in these regions.

The student body also appealed to the Chief Executive Officer and Managing Director of Tata Consultancy Services (TCS) to intervene in the matter and address the recent cancellation of SSC Combined Graduate Level Examination centres in Churachandpur and Ukhrul, Manipur.

Greetings from KSO General Headquarters, an Apex Kuki Student Body

We hope this message finds you in good health.

We are writing to express our concern regarding the recent cancellation of Staff Selection Commission CGL (Tier-1) Examination centers in Churachandpur and Ukhrul, This unexpected decision has caused significant inconvenience to many candidates who had been preparing diligently for the examination and were relying on these centers

The abrupt change has led to logistical and financial difficulties, especially for those now required to travel long distances to alternative centers. This situation has added undue stress and anxiety to the candidates. The road condition from Churachandpur to Mizoram (Aizawl) is very deplorable and is not getting better anytime soon

Since the center is located in Imphal, the candidates belonging minority Kuki community cannot travel to the Imphal valley as there is buffer-zone between the two districts i.e. Imphal valley and Churachandpur

Additionally, the Deputy Commissioner of Churachandpur had provided full assurance regarding the security measures for the smooth conduct of the examination.

including in Manipur, the KSO, however, raised concerns over the abrupt decision by the SSC authorities to cancel the examination centres, scheduled to operate from September 8 onwards.

It also highlighted several key issues, including Security Assurance, Inconvenience to Candidates, Logistical and Financial Burdens, and Travel Restrictions.

The student body has called on TCS to intervene and urge the SSC to reconsider the cancellation, reinstating the examination centres to support the aspirants in these districts.



KWOHR QUESTIONS CREDIBILITY OF MEIRA PAIBIS CALL FOR PEACE AMIDST ONGOING CONFLICT

In a pointed statement addressing the ongoing conflict in Manipur, the Kuki Women Organization for Human Rights (KWOHR) has cast doubt on the moral and ethical authority of the Imagi Meira and other Meitei women's groups. The organization claims that these groups, accused of involvement in violence against Kuki-Zo women, are not in a position to effectively advocate for peace.

KWOHR's critique is based on a controversial remark made by a Meira Paibis leader, who, in an interview justifies the gang rape, and atrocities committed against Kuki-Zo women, the Meitei women leader remarked, "As a woman, I feel pity for them, but it's a war." We hope this quote provides them the same comfort they once extended to us.

The KWOHR's first question for any women's organization, especially Imagi Meira, is whether they possess the moral and ethical authority to demand resolutions to end the conflict and advocate for peace, given their alleged role in the violence. KWOHR reminds the Meitei women of their involvement in the ethnic cleansing, pointing out their direct and indirect participation in war crimes.

Arambai Tenggol allegedly sought the Meira Paibis' blessing before executing their pogrom against the Kuki people. The Meira Paibis are accused of shielding Arambai Tenggol and other Meitei militant groups from arrest and actions by government agencies. They allegedly bought time for attacks on Kuki villages by obstructing security forces, encouraged and participated in mob violence, facilitated cruelty, and undermined the rule of law. Notably, they are said to have rescued terrorists from Indian Armed Forces and obstructed investigations into the looting of state armories, among other actions. If they truly seek resolution, should they not first submit themselves to the law for their alleged crimes before issuing ultimatums?, the KWOHR asked.



KWOHR's critique extends to the state's paramilitary forces, questioning their effectiveness in maintaining law and order amidst ongoing violence. Despite the deployment of 60,000 paramilitary personnel, violence continues, including repeated bombings from the valley to the hills. KWOHR suggests that the security forces have not acted decisively to quell the unrest, raising concerns about their role in the conflict.

The organization also criticizes Imagi Meira and associated groups for allegedly opposing the surrender of Arambai Tenggol and the return of looted weapons. The KWOHR argued that the Imagi Meira is correct in asserting that both the state and central governments share responsibility for failing to resolve the conflict. However, resolution cannot be achieved without holding accountable those involved in orchestrating the ethnic cleansing, including the Meira Paibis, Arambai Tenggol, and Biren Singh along with his allies. Are they prepared to face legal consequences? If so, central agencies would likely be receptive to their demands.

Meira Paibis and other Meitei women's organizations reportedly oppose the surrender of Arambai Tenggol and the looted weapons. The KWOHR accused some Meitei influencers and activists of







providing war equipment to those committing violence against the Kuki people, questioning whether their negotiations prioritize justice for victims or majoritarian interests.

"Imagi Meira's stance on drones is valid as they pose a serious threat to civilian safety and security. Activists like Licipriya and others should be held accountable under UAPA for procuring such dangerous weapons and supporting terrorist organisations like Arambai Tenggol. The evidence against them is substantial, unlike the dubious images and videos used to defame the Kukis. Is Meira Paibis' approach to defamation aligned with their 'This is war' mentality?", questions the KWOHR.

If justice for the victims and restoring normalcy in Manipur is indeed the goal, Imagi Meira and all Meitei CSOs should demand an explanation regarding the leaked audio tape involving Biren Singh. He is responsible for the death of their people, not the Kukis. Defaming the Kukis will not absolve their crimes.

The KWOHR, representing Kuki women, declares that their safety, security, and right to live with dignity and respect lie outside Manipur but within India. Hence, they demand for an expedition of political demand in the form of Separate Administration.

KUKI INPI SADAR HILLS CONDEMNS DRONE ATTACK INCIDENT IN KOUTRUK, CALLS FOR IMPARTIAL INVESTIGATION

The Kuki Inpi Sadar Hills has expressed deep concern over a recent incident in Koutruk involving a drone equipped with an explosive device, reportedly deployed by members of the Meitei Commandos along with their militant outfit to target Kuki village volunteers. The attack failed due to a battery malfunction, and the incident has since been embroiled in controversy, with baseless accusations against the Kuki volunteers suggesting they deployed the device themselves.

The Kuki Inpi condemned the deliberate distortion of facts, stating that such actions only serve to heighten tensions and violence in the region, rather than promoting peace or justice. They criticized attempts to manipulate the narrative to favor one group, warning that such approaches only deepen the divisions and mistrust between the Meitei and Kuki-Zo communities.

The organization raised serious concerns about the impartiality of investigations conducted by the Director General of Police (DGP) of Manipur, alleging a consistent bias in favor of the Meitei majority while neglecting the suffering of the Kuki minority, including the burning



of over 300 Kuki villages. The Kuki Inpi called for a truly independent and impartial investigation into the Koutruk incident and other acts of violence in the region.

The statement emphasized that peace can only be achieved through fair and unbiased law enforcement, urging authorities to hold all parties equally accountable for their actions. The Kuki Inpi warned that selective justice and biased blame will only worsen the conflict and called on all stakeholders to commit to truth and justice to heal the wounds of the affected communities.





BJP MLA PAOLIENLAL HAOKIP WRITES TO HM AMIT SHAH ADDRESSING RK IMO'S ALLEGATION ON ITLF

BJP MLA Paolienlal Haokip has written a formal letter to the Union Home Minister (UHM) expressing deep concerns over recent developments in Manipur. The MLA's communication comes in response to allegations made by MLA Rajkumar Imo Singh against the Indigenous Tribal Leaders' Forum (ITLF), a respected civil society organization advocating for the Kuki-Zo community.

Haokip criticized RK Imo Singh for accusing ITLF of terror activities without credible evidence, calling such claims misleading and harmful to the tribal communities striving for peace amidst ongoing violence. He urged that if Singh is truly concerned about public safety, attention should instead be directed at Meitei civil society organizations like COCOMI and the Haomee Federation. Haokip alleges these groups have been complicit in fueling unrest and have remained silent during the looting of state armories by Meitei groups, which he views as a grave national security issue.

Highlighting the severity of the situation, Haokip noted the immense suffering of the Kuki-Zo community, including the loss of hundreds of lives and the destruction of homes and churches. He criticized the lack of condemnation from Meitei MLAs regarding these atrocities and accused Singh of focusing on demonizing a peace-seeking community rather than addressing the real issues of ethnic cleansing and violence.



The BJP MLA called for the Government of India to expedite a political solution for the Kuki-Zo people, proposing a separate administration in the form of a Union Territory with a Legislature as a means to achieve lasting peace and security. He expressed frustration with the government's delay in addressing these demands, which he believes exacerbates the situation.

Haokip described the Manipur crisis as not merely an ethnic conflict but an issue of state-sponsored persecution and a question of justice and survival for the Kuki-Zo people. He urged authorities to thoroughly investigate the threats posed by Meitei armed groups and to look into leaked audio tapes involving the Chief Minister under Supreme Court supervision.

On Tuesday, Dr. Sambit Patra, the BJP National Spokesperson and Co-ordinator of the North East, had visited the strife-torn state of Manipur. As per reports, unlike his earlier visits, the latest two-day visit was in accordance with specific instructions from the Government of India to take a decisive step for quick restoration of peace in the region.

It was said that except for some top leaders of the Government and BJP Manipur Pradesh, no BJP Ministers, MLAs and the party's office bearers had prior information of Sambit Patra's visit. The Meiteis' valley-based media houses are now abuzz with speculations of possible change of guard for restoration of peace.

Is the Centre planning something big to ensure early restoration of peace in Manipur? Why did BJP's Sambit Patra make a sudden visit to Manipur? Was he assigned to submit a detailed report to the BJP top leadership on the current state of things in violence-hit Manipur?

Notably, the NDA 3.0 Government would be completing 100 days on September 15. Responding to Media's query, Manipur Minister Th. Basanta said that the BJP or the PM had never said that the Manipur crisis would be resolved within 100 days of Modi 3.0 but had stated that all efforts will be made to bring permanent peace at the earliest.

The visit of BJP central leadership to the conflict state is nothing new. Since the eruption of the state-sponsored ethnic cleansing pogrom against the minority Kuki-Zo on May 3 last year, multiple visits have been made by the BJP central leadership but nothing sort of peace came to light even after more than 16 months. Rather, every visit of theirs was marred by escalation of violent aggression from the Meitei radical armed groups against the Kukis, thus pouring fuel to the fire.

Soon after arriving at Imphal, Sambit Patra reportedly held a meeting with Chief Minister N Biren Singh and also one to one meetings at Hotel Imphal with the BJP Ministers and MLAs, barring Kuki MLAs/ Ministers. He also met BJP Manipur Pradesh President A. Sharda, Assembly Speaker Th. Satyabrata and a few intellectuals from the Meitei community.

Sambit Patra also visited Moreh, the border hill town of Kuki-dominated Tengnoupal district.

Certain quarters have expressed strong suspicion that Sambit Patra might have met some Kuki Ministers and MLAs at Moreh.

Media reports stated that Sambit Patra dealt on whether replacing the Chief Minister could check the violence or whether the incumbent Chief Minister should be retained. Reshuffling of the Council of Ministers too reportedly figured at the meeting.

His visit was earlier scheduled to last four days during which he would also visit Churachandpur and Kangpokpi where he could meet Kuki Ministers and MLAs; but the visit was cut short suddenly at the instruction of the Centre. He is expected to present a detailed report to the Government of India about his visit to Manipur. Many political experts and analysts have opined that Sambit Patra's two-day visit is highly significant unlike his previous visits.

It is important to note that the Kukis have been facing the brunt of Meitei atrocities for the last 16 months. The violence is orchestrated and preplanned by N. Biren Singh (as per his incriminating audiotapes) in cohort with his private militia groups.

The position of the Kuki-Zo people is clear. Replacing the incumbent and incompetent chief minister is not the issue anymore. As the two warring communities are already totally separated physically, ethnically, geographically and demographically, there is no question of peaceful co-existence under one administrative unit. The Kukis will not settle for anything less than "Separate Administration" from the communal Meitei government for peace and normalcy to return.





The global community must demand action from the Government of India to end the cycle of violence and impunity in Manipur, ensure accountability, and protect the human rights of all communities.








Since 3rd May 2023, there are numerous allegations, with proofs, of the biased-ness of the state government in tacitly and openly supporting, and facilitating/ arming the meitei radicals & terrorists to fight against the Kuki-Zo people. Even then, no action has been purportedly taken against any meitei person, private or government servant, for acting against the Kukis, thereby raising questions about the state government's role in this ongoing violence against the Kukis. This alleged complicity of the Meitei government is proving to be an added ammunition to those numerous analysts who termed this ongoing violence as "state-sponsored."

In this series, we are asking very simple questions, along with the evidences, for the Meitei state government to answer:

1) Who is this person? When was he recruited to IRB? Who authorized his transfer from IRB to Police Department, and then to UNLF-MPA? Any FIR lodge against him or against any responsible person by Meitei Police or CBI or NIA? Who will be accountable for violation of the concerned law/s?



2) How come militants / non-police personnel are allowed to wear Police uniforms? Who stitched those uniforms? Any FIR filed by Manipur Police or NIA or CBI against anyone for impersonating the police? Why the then SP of Tengnoupal (a Naga) was made a scapegoat and transferred after the incident, while no action was taken on any Meitei office holder?

Who gave these non-Police Meitei persons arms and ammunition, with a licence to kill the 'Kukis'? From which Police Station are these arms taken from -Kakching/Pallel/Thoubal? Were the weapons returned after the incident? Any FIR or Any action on record?



Another glaring example of the Meitei Police allowing the Meitei terrorists to join them by giving them uniforms allegedly with a view to escape the radar of the Army-checking at various check-posts. Who devised such a plan to ferry the militants in the guise of Manipur Police? It has been alleged that all these plans are devised by Col. (Retd.) Nectar. Is it true? Any suo-moto FIR/ Complaint lodged by Meitei police against such individual/s for defaming the Police uniform or for impersonating a SI ranked Police Officer? If no complaint/FIR, why?



Who provided Khambaton Meitei with government issued arms (5.56mm INSAS) and uniform? Any suo-moto FIR/ Complaint lodged by Meitei police against such individual/s donning police gear and using police weapon? If no complaint/ FIR, why? Was the INSAS looted from Police Armoury? If yes, any step taken or any arrest made to recover the said arm?



"Let's kill all the Kukis" reads the whatsapp 6) status of Mr. Soisenba Oinam, who is armed with a .303 rifle and accompanied by the Meitei Police Commando. Has any FIR been filed against him for inciting communal violence or participating in to use criminal force or violence under Section 153/153A of IPC or Sections 192/196 of BNS? Why no action taken by Meitei Police, under the Arms Act, for possessing a firearm that is not authorised for public?
















"Let's fight the Kuki slaves" reads the Instagram status of Mr. Sana Tmba while wearing uniform of Meitei Police Commando and armed with 5.56 mm INSAS Rifle. Who armed them with the government weapons, and who clothed them with Commando uniforms? Any suo-moto FIR filed under SC&ST Prevention of Attrocities Amendment Act, 2015 (for insulting the ST Kuki community and calling them slaves) or u/s 504 IPC or u/s 352 of BNS, 2023 (for insulting with an inient to provoke breach of peace)? If not, why?



Dated Aug 3, 2023; Location Bishnupur -Churachandpur border: On the day of the Meira Paibis attempted march to Churachandpur, the Meitei militants were given a free hand by the Meitei Police of Bishnupur to create riot in case of need. As per reports the women were at the forefront and acted

as human shields for the Meitei militants. Later, these militants fired upon the Indian Army and RAF, who then retaliated in a controlled manner, and prevented situation from turning volatile. A photo was captured wherein one of the militants carrying a 7.62 mm SLR was briefed by one of his fellows, while the Meitei commandos remained a mute spectator to the ongoings. Why no arrest made and no FIR filed against any of the militants for carrying sophisticated arms in contravention to the Arms Act, 1959? Why no FIR on Meira Paibis for attempting to disturb peace?

During the stand-off, it was learnt that the biased Meitei Police saw the neutral central forces as their enemy and even fired at them for performing their duties (by stopping the Meitei militants from reaching Churachandpur). Why no FIR registered against Meitei Police for attempting to harm the central forces? Why no CBI/ NIA has taken note of this issue?



Centre should focus on recovering all the looted arms and ammunitions, and should ensure that all Meitei militants are either flushed out or contained before targeting the Kukis for guarding their villages and people. On the first week of May 2023 when hundreds of Kuki villages were burnt and hundreds of Kukis killed by Meiteis (police,















commandos and militants) where were the central forces?

How many of the looted arms / ammunition of the Valleys have been recovered so far? How is it possible that the sole SoO signatory of the VBIG, the UNLF-MPA, are seen wherever attacks on Kuki villages are happening?



10) A self-proclaimed environmentalist is seeking sponsorship to purchase – Portable radars (3 nos), drone jammers (6 nos), bullet proof (3000 pieces), thermal drones (100 nos) etc. Was there any suo-moto enquiry done by DGCA (the regulator on drones) or even the meitei police as to why so many drones are sought to be purchased? There were reports that many drones were carried by Licypriya as an airline passenger? How did the Bureau of Civil Aviation Security allowed so many drones to be carried on airplanes? Any exemption for Licypriya? How were the drones utilized? One is

tempted to conclude that these were used by the Meitei militants to monitor the movements of the Kuki people and the Indian Army/ CAPF, and for attacking the Kuki villagers.


