'NO UNLF DESIGNATED CAMPS IN HILL DIST,' KUKI INPI SADAR HILLS, HMAR INPUI JOINS CHORUS, ASKS AUTHORITY CONCERNED TO ACT RESPONSIBLY

Following the footsteps of several Kuki-Zo civil bodies of Manipur's Tengnoupal district, several other top tribal bodies have come out in strongly opposing the proposed locations for designated camps of the UNLF(P) surrendered cadres who had recently inked 'Peace Agreement' with the Government of India.

Vehemently condemning the Manipur government's proposal to locate 'Designated Camps' for UNLF surrendered cadres in tribal areas of Manipur, the Kuki Inpi Sadar Hills, or the KISH, strongly opposed the recent proposal put forth by the Manipur Government to establish designated camps for valley-based secessionist militants in Kuki-Zo tribal areas.

KISH Information and Publicity Secretary, Thanglenhao Chongloi, said that the unscrupulous state government's proposal is a cover-up of a "sinister stratagem to grab tribal land" and a game plan to openly pursue its campaign to annihilate the Kuki-Zo community.

"The Kuki-Zo people will fight tooth and nail against any attempt to use our land as a safe haven to shelter an outlawed terrorist group whose only intention is to wipe us off the face of Manipur and beyond," he asserted.



MEITEIS INFLICTS SERIOUS INJURIES ON TANGKHULS

Three Tangkhul men were beaten by alleged unidentified Meitei armed miscreants at Sawombung, Imphal on the night of December 3, 2023, Sunday.

The three persons were on their way back to Ukhrul from Imphal. The Scorpio vehicle in which the trio was travelling was first stopped by womenfolk at Sawombung, Imphal at around 9 pm where they were asked about their identity. Even after identity verification of the trio was made, at least 5 armed miscreants, alleged to be Meiteis, whisked them away in a white Gypsy and proceeded to beat them black and blue.

As narrated by one of the victims, “The Meira Paibis were appealing the armed miscreant to let us go since they had identified our identity. However, we were forcibly taken away to another place and more people joined the group. We were taken to a nearby bridge and after interrogation, we were made to lie down and beaten black and blue. They accused us of being a spy/informer of Kuki-Zo which we denied flatly. Despite telling them the truth, they kept on beating us and threatened to shoot us with the weapons they were carrying. They even started counting 1-10...”

Further, the victim continued, “During the interrogation, they even accused us that the magnetic hat clip ball marker which was in the hat/cap was a symbol of Kuki-Zo and they took away the hat clip ball marker. They even placed the gun on our neck and threatened to shoot

us. After beating us black and blue at the bridge, they took us to another place and told us to run, but we objected to that. It was only after the guy on an Activa scooter called up one Tangkhul lady to ascertain and confirm our villages through loudspeaker over the phone. Only then were we released.

“They handed our vehicle back later and allowed us to proceed to Ukhrul. By that time, it was already 1 am, Monday.”

It may be mentioned that stranded Tangkhul students mostly from Dhanamanjuri University (DMU) and Manipur University came under several attacks, were greeted by burning tyres, stone pelting, sticks, air-guns pellets and sling-shots from unidentified miscreants, suspected to be Meiteis at the same location in Sawombung, Imphal while they were en-route from Imphal to Ukhrul during early May 2023 when the ongoing Manipur ethnic conflict erupted. The students were being evacuated from Assam Rifles transit camp.

It may be recalled that during Manipur Chief Minister Biren Singh’s visit to Ukhrul district headquarters on 18 October 2023, Singh had remarked about the blood relation between Tangkhul and Meitei communities in the State. However, the claim was refuted by various Tangkhul Civil Society Organizations including the Tangkhul Naga Long (TNL) and the NSCN(IM).

ARMS AND AMMUNITION RECOVERED IN IMPHAL EAST

A combined team of Manipur police and Assam Rifles recovered and seized arms and ammunition from the general area of Khamenlok and Nongshum, Imphal East district on Monday.

In the search operation, various arms and ammunition were found concealed at the general area between Khamenlok and Nongshum village at around 2.10 pm in the presence of witness suspected to be kept hidden by unknown miscreants.

The arms and ammunition included one SMG Carbine bearing registration number 18251252 with one empty magazine; one SMG Carbine bearing registration number 15228653 and butt number 148 with one empty magazine; one SMG Carbine bearing registration number 16200912



with one empty magazine; 15 HE 36 Hand Grenades without detonator; six WP Smoke Grenades without detonator; 18 2 inch Motar HE Bombs and six No. 75 MK-2 detonators.

MEITEIS' ST DEMAND MISSED CALL CAMPAIGN SCANDAL: FRAUDULENT CAMPAIGN NOTICED ON SOCIAL MEDIA PLATFORM

Unable to reach their desired target of about 5 lakh missed calls to a designated number as part of a campaign for inclusion of Meitei in ST category, the Meiteis have now fraudulently put up the given number 8732042511 disguised as a "contact point" for online shopping. This is a scandalous effort deviating from the genuine cause.

Since November 20, the Meetei (Meitei) Tribe Union (MMTU) had begun the mass missed call campaign titled "Campaign For A Better Manipur With Equal Status" for inclusion of Meetei/Meitei in the Scheduled Tribes list under Article 342(1) of the Indian Constitution.

The campaign will continue till December 20, 2023, as per Mutum Churamani, General Secretary, MMTU.

The so-called Meitei Tribe Union had urged peoples' representatives such as MPs, MLAs as well as VIPs, bureaucratic officers and members of political parties, Meitei diaspora, local clubs, Meira Paibis, and the Meitei populace to give a missed call to the assigned mobile number +918732042511 without fail for inclusion of Meitei in ST category.

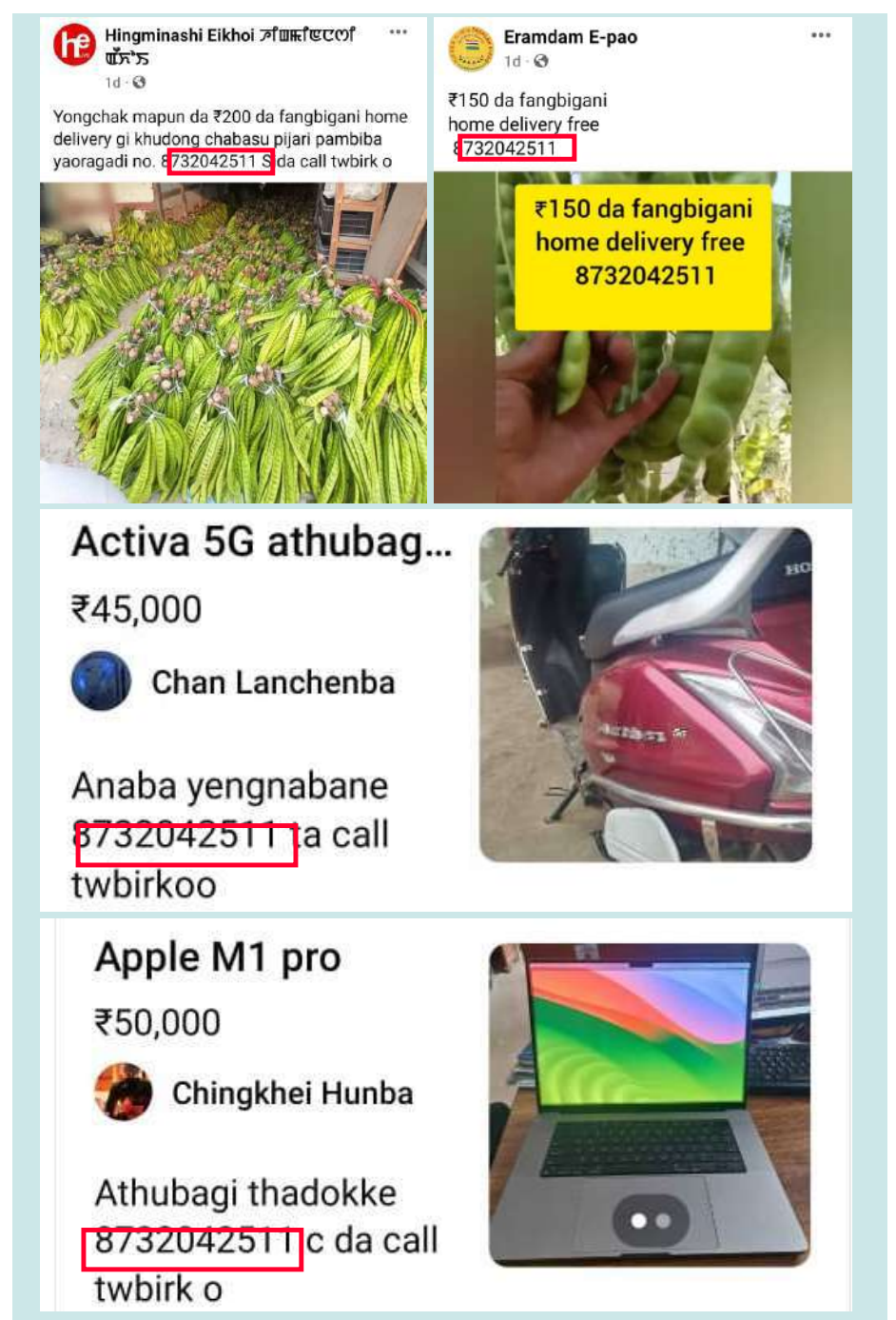
However, the Meiteis' innate nature and habit of cheating, lying and deceiving has once again surfaced on social media platforms wherein the assigned mobile number given by the concerned organising bodies is now no more put up for the genuine cause but advertised in a mischievous way to deceive the people. Meitei social media users are now deliberately cheating their own people by putting out the assigned number 8732042511 alongside highly demanded goods/vegetables and advertising to the public to call for home delivery on online shopping groups or Facebook pages.

Their mischievous and scandalous act, however, will not get desired results as the Meitei community's hopes of being included in the ST category is just a day dream.

MIZORAM'S STANCE ON MANIPUR WILL NOT CHANGE, SAYS CM-ELECT LALDUHOMA

A day after the Zoram People's Movement stormed to power in the Mizoram Assembly elections, Chief Minister-elect Lalduhoma said that his government would continue to provide shelter and assistance to refugees from Myanmar and those displaced from Manipur.

Outgoing Chief Minister and Mizo National Front leader Zoramthanga had continued to support the displaced during his government, refusing to follow the Centre's directive in September to collect biometric data of Myanmar refugees in the state. He had also welcomed the Kuki-Zo people fleeing the ethnic conflict in Manipur.

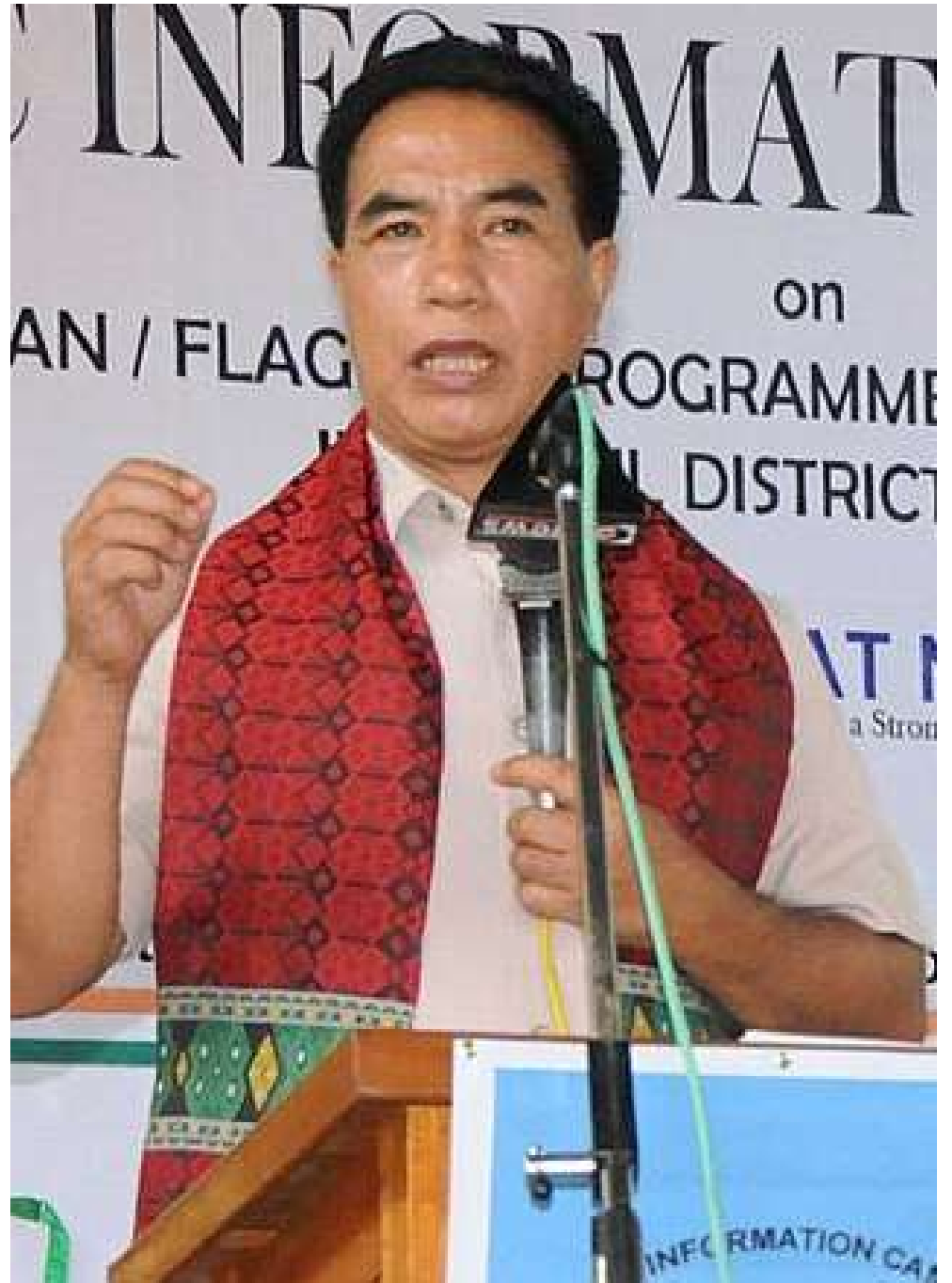
Mizos share strong ethnic ties with Manipur's Kuki and Myanmar's Chin tribes.

Since February 2021, nearly 35,000 Chin refugees from Myanmar have crossed over to the state. Around 12,000 Kuki-Zo people from Manipur have also fled to Mizoram after ethnic clashes between the Kuki and Meitei communities broke out in the state in early May.

In the run-up to the Assembly elections, the Mizo National Front had projected itself as a Zo nationalist party and warned that another outfit might not be strong enough to withstand the Central government's pressure to push back the refugees to Myanmar.

However, after emerging victorious in 27 out of 40 seats in the state, the Zoram People's Movement has said that the state's position on the issue of refugees would not change.

"The issue is humanitarian," Lalduhoma, a former Indian Police Service officer, told Scroll.

LALDUHOMA TO TAKE OATH AS MIZORAM'S NEXT CM ON DEC 8; ZORAMTHANGA RESIGNS AS MNF PRESIDENT

President of the Zoram Peoples' Movement (ZPM), Lalduhoma, who steered his party to a landslide win in the just-concluded Mizoram Assembly elections, is all set to become the northeastern state's next chief minister.

The opposition party bagged 27 of the 40 seats in the state assembly pushing the ruling Mizo National Front (MNF), which secured 10 seats, to a distant second spot. The other seats were bagged by the Bharatiya Janata Party (2) and the Congress (1).

"There will be a meeting of all newly elected MLAs at the party president's residence in Aizawl on Tuesday evening where he will be declared as the ZPM candidate for the chief minister's post," said newly elected ZPM MLA Lalthansanga who defeated MNF president and chief minister Zoramthanga.

Lalduhoma, a 74-year-old Indian Police Service (IPS) officer-turned politician, had already been endorsed last year by the ZPM's elderly council, called Val Upa Council, as the party's chief ministerial candidate for this election.

"We are most likely to stake claim to form the next government on Wednesday. Swearing in of the new chief minister and his cabinet will be held on December 8," said Lalthansanga.

According to people familiar with the matter in the ZPM, the swearing in would most likely be held at the Raj Bhawan though many in the party had wanted it to be held at a public place so that more people could take part.

Speaking to HT on Monday, Lalduhoma had stated that his government's three prime focuses would be welfare of farmers, fiscal reforms and strict measures to prevent corruption.

"To support farmers of the state, our government



will procure ginger, turmeric, chilly and broomsticks at a minimum pre-determined price. The finances of the state are in shambles. We will constitute an expert committee and put fiscal reforms in place," he said.

"Our government will adopt a policy of zero tolerance for corruption and will grant permission to CBI to act on it. Other focus areas of the new government will be decided after the swearing in takes place," Lalduhoma added.

In another development, a day after his party's loss, former chief minister Zoramthanga resigned on Tuesday as the president of the MNF—a post which he had been holding since 1990.

The 79-year-old submitted his resignation letter to former deputy chief minister Tawnluia, who is the senior vice-president of the party. On Tuesday, the MNF named Lalchamdama Ralte as the party's legislature party leader in the new assembly.

CONGRESS SLAMS PM MODI FOR HIS SILENCE OVER MANIPUR ISSUE, MALLIKARJUN KHARGE ASK WHO IS RESPONSIBLE FOR DEMOLITION OF LAW AND ORDER

The Congress, on the ongoing violence in Manipur, criticized Prime Minister Narendra Modi-led government, emphasizing that the state's situation is far from normal. They also demanded that the prime minister hold a discussion to find a solution which is acceptable to all stakeholders.

Congress General Secretary Jairam Ramesh on Tuesday questioned Prime Minister Narendra Modi's silence on the Manipur situation. He pointed out that despite the Home Minister's claim of restored peace in the northeastern state, the ground realities present a different picture.

While slamming the Modi government for the situation in the state, Congress president Mallikarjun Kharge asked, "Who is responsible for the complete demolition of law and order in the state?"

"Who is responsible for the Chief Minister brazening it out and sticking to his untenable position?"

"Why has the Peace Committee constituted by the Union Government not done any visible work to restore peace, normalcy and harmony in Manipur," Kharge asked on X.

"The Congress party along with several political parties in Manipur have demanded, and again repeat, that only a detailed discussion with the Honourable Prime Minister can find a solution to the conflict which is acceptable to all stakeholders," he said.

"We sincerely hope that he obliges," he added.

At least 13 people, suspected to be the cadres of the outlawed PLA terror group, were killed after a gunfight in a remote border village of Manipur's Tengnoupal district on Monday, officials said.

Unmasking the Truth: The Controversy Surrounding the Demise of 13 Meitei Militants in Kuki Ancestral Land

The Hindustan Times and other leading newspapers reported that the recently deceased 13 Meitei militants were suspected to be cadres of the PLA. Meanwhile the N. Biren Singh government and the Meitei society at large believe they are innocent Indian civilians. Nothing can be further from the truth. It has been learned and confirmed from very reliable sources that these men were actual PLA cadres who recently completed their training. The PLA is a proscribed terrorist group banned under the UAPA. According to the MHA, the PLA has been involved in attacks on security forces, police, and civilians in Manipur, as well as activities detrimental to the sovereignty and integrity of India. The Indian Army especially the Assam Rifles aims to combat their “secessionist, subversive, terrorist, and violent activities.”

What actually happened?

These PLA cadres had infiltrated into Kuki ancestral lands in India with the help of a local non-Kuki tribal guide. These 13 Meitei militants then ransacked, looted and terrorised a Kuki village due to which the innocent Kuki villagers fled the village and hid in the jungles. The villagers reported that these Meitei militants had also looted cash from the village church. After causing mayhem and havoc for 5 hours, the Central

Security Forces found them dead. The villagers were surprised when they heard the news of their demise.

Ex-Gratia for Anti-Indian Meitei Militants? – Pabung Ngaore

It has been learned that these 13 PLA cadres are residents of Manipur, evident from the Meitei government’s quick response in giving their details. Added to this, it was decided in a cabinet meeting held today in our neighbouring state capital, Imphal, that these anti-Indian Meitei militants are to be given ex-gratia by the Manipur government. This is unconstitutional. N. Biren Singh has forgotten his oath-taking ceremony where he swore to uphold the Constitution and protect India’s sovereignty from threats, domestic or foreign. This clearly shows the nexus between Biren and proscribed Meitei terrorist groups. The state is now officially making plans to channel state funds to benefit the cadres of VBIGs - dead or alive. Meanwhile the gullible Meitei populace is being fed a farrago of lies, distortions and misrepresentations which are selective and self-serving, herding the Meitei community into isolated echo chambers which is insulated from truth and reason. 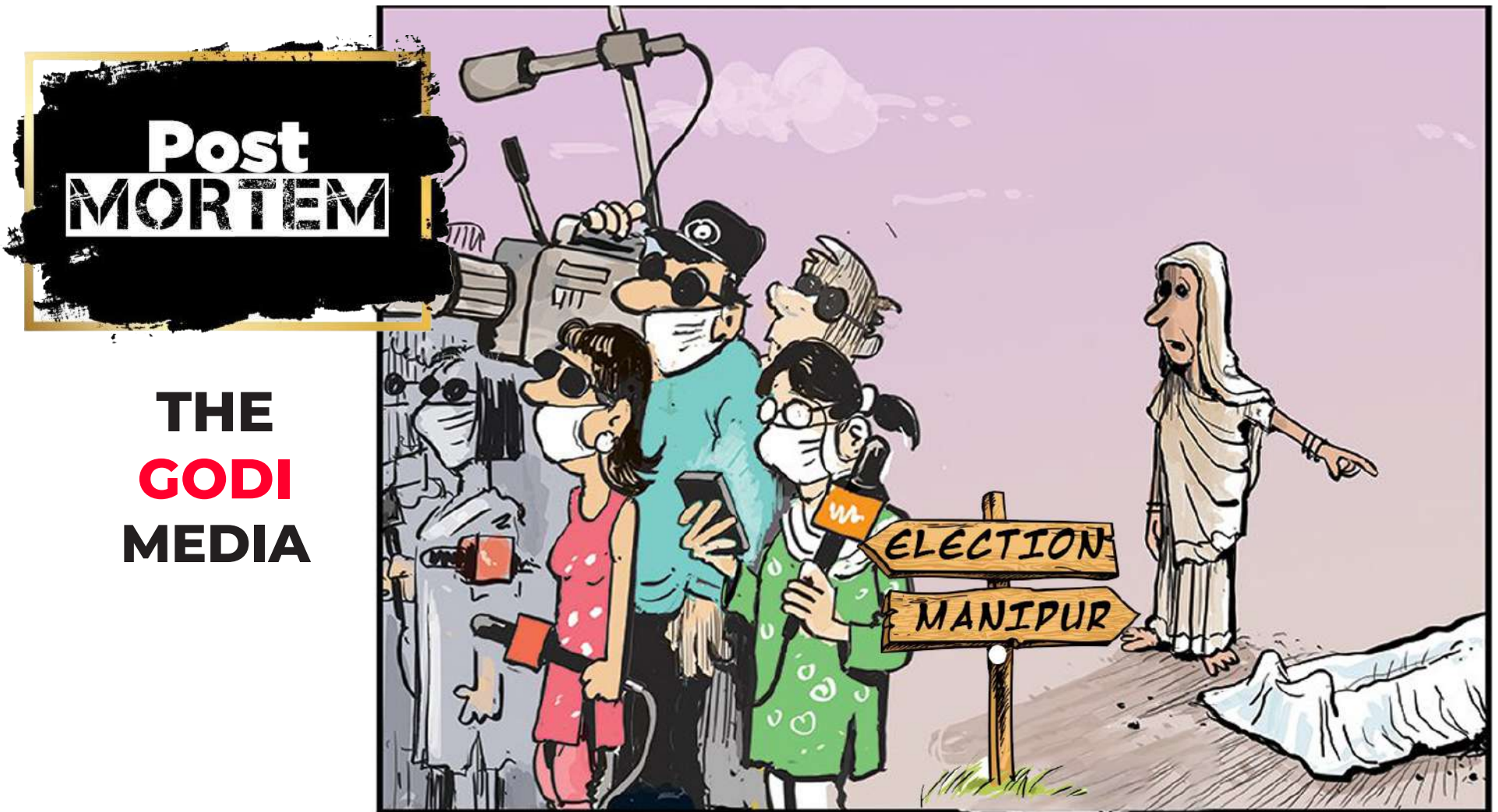

harmed. Before they could carry out their hideous anti-Indian mission of annihilating the Kukis from their ancestral lands, fate had other plans. Just like God rescued Daniel from the mouth of the starving lion, the Kukis are safe, FOR NOW. God helps those who help themselves. Which is why we need the Central Security Forces to step up their efforts in restricting the movement of VBIGs including UNLF(Pambei) and Manipur Police Commandos. Additionally, to ensure the preservation of peace and stability, it would be beneficial to relocate those Meitei army officers currently stationed in Kuki ancestral lands to alternative postings. The basis for this suggestion is not a reflection on their integrity and honesty; instead, it arises from the substantial trust gap between the Kukis and Meiteis, a divide that has been exacerbated by the deliberate cultivation and sowing of communal discord by N. Biren.
