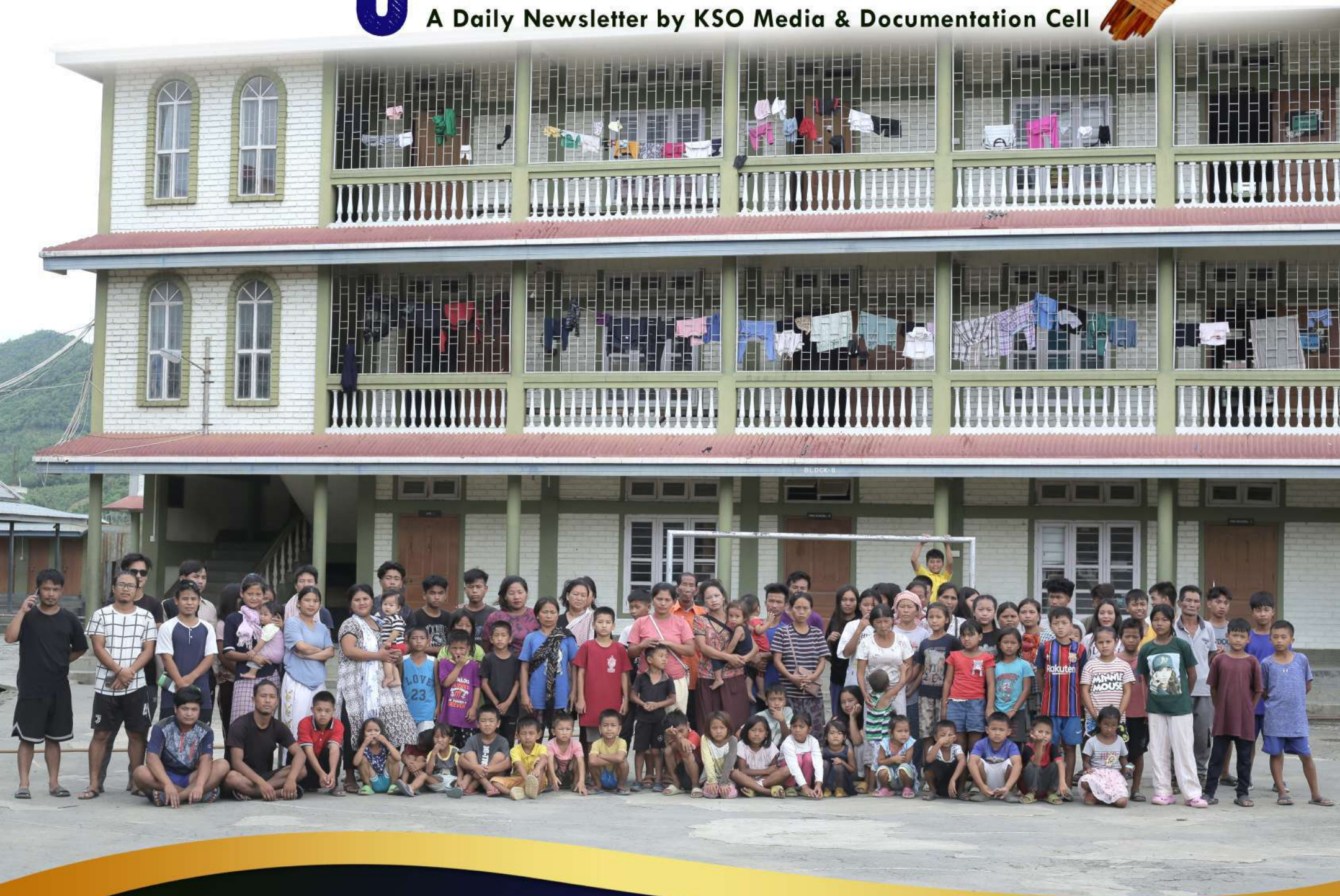

SET UP JOINT TASK FORCES IN NE, PM MODI INSTRUCTS SECURITY FORCES

Prime Minister Narendra Modi instructed the security establishment during the annual police and intelligence chiefs' conference that concluded on Sunday to create joint task forces (JTFs) in the northeastern states for counter-insurgency operations along the lines of those in the left-wing extremism (LWE) theatre, people familiar the development said on Monday.

The JTFs, officials who didn't want to be named, may be formed between the states, central paramilitary forces and intelligence agencies for "coordinated" operations to give a blow to the insurgents, particularly those operating in areas bordering Myanmar and flee to the other side after carrying out attacks.

A similar format is currently followed in states affected by left-wing extremism, with forces of several states including Chhattisgarh, Andhra Pradesh, Telangana, Odisha and Jharkhand often carrying out operations jointly with the paramilitary forces.

"A blueprint for the JTFs in the north-east will soon be prepared. It could be two states like Assam and Arunachal Pradesh coming together, or Manipur and Nagaland joining hands to carry out operations," said one of the officers cited above.

The JTFs, said a second officer, will deal with a whole gamut of security challenges like insurgent groups, illegal entry of persons, drugs and gold smuggling, etc.

The people cited above added the Myanmar situation and free-movement regime (FMR) at this border was also discussed in detail in one of the sessions during the director generals of police/inspector generals of police (DGPs/IGPs) conference. Under the FMR with Myanmar which borders four Indian states -- Mizoram, Manipur, Nagaland and Arunachal Pradesh -- every member of the hill tribes, who is either a citizen of India or a citizen of Myanmar and who is resident of any area within 16km on either side of the international boundary can cross the border on production of a pass with on year's validity and can stay up to two weeks per visit.



The government is planning to end the FMR to stop the influx of illegal immigrants, as reported by HT last week.

Apart from the JTFs, illegal immigration and drugs smuggling activities at the Indo-Myanmar border, there was discussion on China's activities as well, said the second officer.

The PM has asked the government officials to visit the last border villages so that the local population feels safe.

Besides, the PM asked the police and intelligence chiefs of to "think imaginatively" to convey the emotional spirit behind recently enacted three criminal laws, which he said were framed with a "citizens first" approach.

The three-day annual conference was held in Jaipur from January 5 to 7, in which discussions took place on various national security issues and progress on last year's agenda points.

SECURITY ADVISOR KULDIEP SINGH BRIEFS MANIPUR GOVERNOR

Manipur Security Advisor, Kuldiep Singh met with Governor of Manipur, Anusuiya Uikey today at Raj Bhavan and apprised of the present law and order situation in Manipur since the outbreak of the ethnic strife on May 3 last year.

According to a Raj Bhavan statement, Kuldiep further briefed the Governor about the security arrangements taken up to restore peace and normalcy in the state and the deployment of security forces in vulnerable areas, mainly in the fringe foothill areas to prevent unwanted incidents.

Meanwhile, Anusuiya Uikey advised the Security Advisor to put all efforts to bring back normalcy and peace in Manipur.



SPEAR CORPS INDIAN ARMY VISITS STRIFE-TORN MOREH

Lieutenant General HS Sahi, AVSM, YSM, SM, General Officer Commanding (GOC) Spear Corps, visited the Assam Rifles Battalion in Moreh town of Tengnoupal District in Manipur on January 9 and undertook a comprehensive security review.

During the visit, the GOC engaged in a comprehensive interaction with the Civil Society Organizations (CSOs) wherein, aspects of early normalcy were discussed, stated a press release issued by PRO and spokesperson, Ministry of Defence, Manipur, Nagaland and Southern Arunachal Pradesh.

The visit was aimed at enhancing coordination, understanding ground realities, and fostering open communication channels between the military leadership and operational units, stated the release.

In its official twitter account Spear corps, Indian Army tweets, "The Corps Commander appreciated the operational preparedness and synergized efforts by the army and Assam Rifles with all stake holders. Meaningful discussions with CSOs were also held for ensuring peace and stability in the area."



Sources said that the Kuki-Zo civil society organisations functioning within Tengnoupal district, particularly Moreh CSOs, have urged the visiting official to withdraw the communal state forces from the border town to ensure peace and tranquility. Until and unless the communal police commandos are removed from the hill town, peace and normalcy remains a far cry.

FMR ISSUE: BIREN SINGH CANNOT DICTATE THE POLICY OF NORTHEAST, SAYS RPP PRESIDENT JOEL NAGA

Commenting on the demand made by Nongthombam Biren Singh to the Centre to end the Free Movement Regime along Indo-Myanmar border, the President of Rising People's Party, Joel Naga, has said that the Chief Minister of Manipur N. Biren Singh cannot dictate the policy of the Northeast.

Joel Naga made the statement in a recent interview with East Mojo news portal on Wednesday. Joel said, "Biren Singh has been very vocal about scrapping the FMR. Biren cannot dictate the policy of Northeast and it is unbelievable that the central government is taking Singh's policy at face value."

"The chief minister should have put his house in order in Manipur before and after the violence," said Joel, and added that it was because of Biren's communal policies that the violence had happened in Manipur. He dehumanized the whole Kuki-Zo people as illegal immigrants, opium and drug dealers, and it is the reason why violence has been continuing in Manipur for 8 months.

Joel said that he did not subscribe to Biren's statement that the illegal immigrants in Manipur are causing problems in the State. The chief minister is talking in terms of lakhs of illegal Kuki immigrants which certainly is not possible, he added.

RPP President noted that the Kukis since 18th century have been serving the Manipur Kings as soldiers and militias and as such, all of a sudden in the 21st century blaming the Kukis as illegal immigrants is not buyable.

Once the FMR is scrapped, there will be border fencing which should not be done. The border fencing will tear families apart and it will hurt the sentiments of the Nagas, thereby peace will be shattered, he stated.



Regarding no official statement from the Centre to scrap the FMR, Joel said that the government probably knows that this is a dangerous move. If the government of India moves ahead with a policy to scrap the FMR, then as far as Nagaland is concerned, it will shatter the fragile peace which is already in place in the State since 1997 because this is a very emotional issue, he added.

"The Government of India should be very wise and exercise its wisdom and ensure that the fragile peace which is in place in Nagaland should not be shattered because of Biren Singh's policy."

Joel asked, "Why should the Modi government backtrack its decision or action and policies because of Biren Singh? This is not acceptable."

The RPP president further said that many people have families living across the border in Burma and they have been forming links with each other for the last 60 to 70 years and there has been free exchange of movement across the border.

VILLAGES, ORPHANAGE HOME, IDPs RELIEF CENTRE, CHURCHES, CIVILIAN HOUSES IN MOREH BOMBARDED ALLEGEDLY BY “FRIENDS OF THE HILL PEOPLE”

A tragic event had unfolded in the Kuki hill town of Moreh since the start of New Year day. On January 9, powerful bombs were rained down on the Kuki-Zo localities of Moreh and the surrounding villages. According to sources and video evidence available on social media platforms, the Assam Rifles, labeled as Friends of the Hills people, turned their weapons against the Kuki civilians.

Displaying a concerning disregard for the safety of civilians, mortars were fired allegedly from Chavangphai/S. Moljol, Gate No. 4, by the so-called “Friends of the Hill People” thereby hugely impacting the civilian areas of P. Laijang, Munpi, and W/No.7. Though there were no reports of human casualty, the indiscriminate shelling and firing caused extensive damage to civilian houses and properties in Kuki-Zo localities including T Yangnom, New Moreh, S Moljol and SL Munpi village.

The brutality of indiscriminate bombings also hit Jehovah Jireh Children Home, Relief Centre for Internally Displaced Persons and Churches, causing extensive damage to properties. Over 50 children are staying in Agape Children Home and around 90 IDPs are taking shelter at IDP Relief Centre, New Moreh. The temporary kitchen erected at IDPs Relief Centre and properties belonging to IDPs were also destroyed by the impact of the explosion.

The indiscriminate shelling of bombs towards civilians and Orphanage Home, IDPs Relief Centre, Church and Educational Institutions perpetrated by the supposedly neutral forces indicates a blatant disregard of the rights of peoples and a blatant abuse of human rights.



This raises questions about the Assam Rifles’ (Sentinels of the North East) role in protecting civilians and as well as concerns about potential support for Meitei militants and communal state police commandos. A serious question persists regarding the integrity of their actions.

Is the ADGPI - Indian Army, Eastern Command, neglecting its fundamental duty of protection and rather choosing to support Meitei militants and state police commandos instead?

AFSPA is not a license to kill and doesn’t carry an irrevocable inbuilt immunity that is not challengeable. Resorting to indiscriminate shelling towards civilians to control the highly charged situation in the midst of escalating tension between the warring communities is absurd. Moreh is not Myanmar.

BREAKDOWN OF LAW AND ORDER IN THE IMPHAL VALLEY: 80-YEAR OLD WOMAN FOUND BRUTALLY KILLED

Tension prevailed in the Yairipok area of Thoubal district after an 80-year old woman was found brutally murdered with her throat slit at her elder son's residence on Monday evening.

Family sources said the gold chain of the deceased, identified as Keisham Radhe, was also missing.

The police have registered a case in this connection and launched an investigation to nab the unidentified criminals.

At around 4pm, the deceased, who used to live with her younger son, went to her elder son's residence at a nearby locality, the sources said, adding that her body was found in the kitchen. No one was there in the house when she reached there, sources further said.

Since violence broke out in the state of Manipur, breakdown of law and order in the Imphal valley is a matter of grave concern, signaling challenges to the overall security and stability of the area. This deterioration manifested in various forms, including an increase in criminal activities, civil unrest, or a lack of effective law enforcement.

A rise in criminal activities such as theft, robbery, and violence undermine the safety of residents and erode public trust in law enforcement. Political or social tensions escalate into civil unrest, leading to protests,



demonstrations, and potential clashes between different groups. This unrest strain law enforcement resources and create an environment of insecurity.

There is perceived corruption within law enforcement agencies, public trust has diminished, leading to a weakened rule of law. This emboldens criminal elements and contribute to disorder.

It is crucial for authorities to assess the specific causes of the breakdown of law and order in the Imphal Valley and implement targeted measures to restore security, maintain public order, and uphold the rule of law.

MEITEIS' ENDEAVOUR TO DISSEMINATE FALSE INFORMATION VIS-À-VIS THE FALSE BOHEMIAN CLUB REPORT

Meitei propagandists have stooped to a new low by pretending to be associated with a San Francisco-based club and spreading a completely false narrative linking Kuki-Zo tribals to ISI and the Chinese Communist Party. The authentic Bohemian Club in the US has verified that they did not publish any such report. Prior to this, Meiteis went to the extent of creating a fictitious news story on a fabricated US and UK Times website to promote their narratives. The extent to which the Meiteis are willing to go to advance their aggression and subjugation of the minority Kuki-Zo tribals in Manipur is truly alarming and raises concerns.

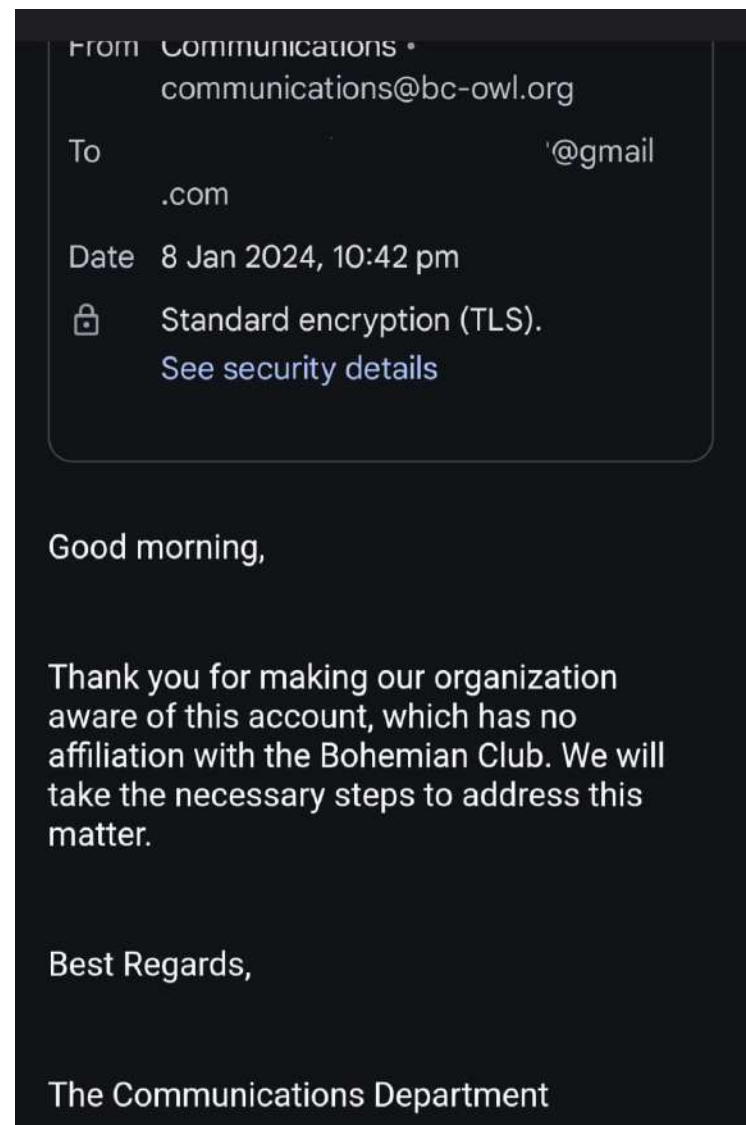
The Meitei propagandist, impersonating the 'Bohemian Club,' a private city clubhouse in the Nob Hill district of San Francisco, California, and the Bohemian Grove, published a report titled "The Red-Green Sinister Coalition: The ISI and CCP come together in the US to fund Anti-India campaign on Manipur violence." The report intends to mislead the gullible public by disseminating false information using the name of the reputed club.

The false report stated that a dissident from the breakaway group of Kuki-dominated anti-India group in the US reached out to a member of Bohemian Club studying at the University of Texas at Austin. The revelations made by him on Manipur crisis led to an investigation by the Bohemian Club, that could shock the policy communities in India and the US, it claimed.

The report alleged that The North American Manipur Tribal Association (NAMTA) based in the United States collaborated with several international organizations and purportedly provided financial support for activities deemed anti-India. The report inaccurately attributed the campaign in Manipur to a coalition involving China, Pakistan, and Khalistani elements.

The report concludes by saying that the Bohemian Club has done its part in exposing the nexus of the anti-India gang and expects that the relevant authorities and stakeholders would take cognizance of and come ahead to neutralize the sinister campaigns.

The NAMTA in their X handle clarified that an anonymous



X/Twitter handle that impersonates the Bohemian Club, an established US-based organization, has been spreading disinformation about NAMTA as an organization and associated individuals who are completely innocent of the baseless claims. The Association calls upon all rational minded individuals to reject unsubstantiated smears and outrageous allegations to spread disharmony in Manipur, India and beyond.

The Bohemian Club itself has clarified the misinformation report informing that the Club will take the necessary steps to address the matter, which has no affiliation with the Bohemian Club.

In summary, Meiteis have excelled in spreading inaccurate or deceptive information, along with leveling groundless and unsubstantiated allegations.



NARCISSIST BIREN CONTINUES TO DEHUMANIZE KUKI-ZO POPULACE EVEN AFTER NINE MONTHS OF HIS ETHNIC CLEANSING CAMPAIGN

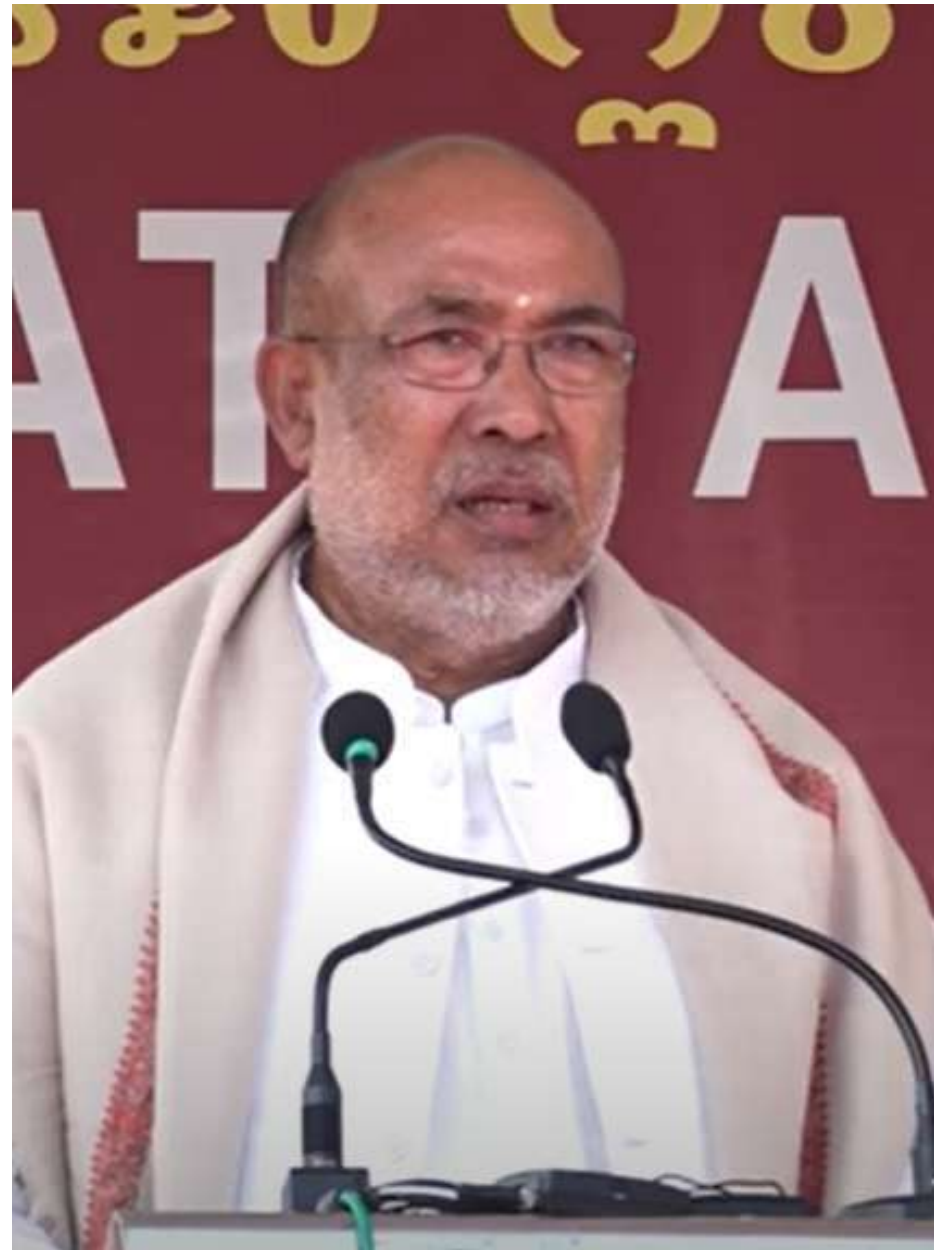
Meitei Chief Minister and narcissist N. Biren Singh is continuing his dehumanization of the whole Kuki-Zo populace even after nine months of his ethnic cleansing campaign in the State. Averse to peace in his inner thoughts, he continues to instigate the insane Meiteis to annihilate Kuki-Zo people from their ancestral hill town of Moreh.

On the occasion of 190th death anniversary of Maharaja Ganbhir Singh on Wednesday, the chief architect of the violence, N Biren Singh, has said that he is ready to resign if the government measures against the use of drugs and its campaigns against the influx of unauthorised immigrants to contain the situation in the state are found to be unconstitutional.

“What exactly was the fault and unconstitutional act of the Manipur government which led to the attacks and burning houses of ordinary people? If there was anything that was unconstitutional in the government act against drug campaign and against the influx of illegal immigrants I will immediately resign. I have to protect and implement the Constitution, which is my responsibility,” said N Biren Singh.

Finding an escape route for his deep involvement in the state-sponsored ethnic cleansing pogrom on the Kuki-Zo people, Biren continuously changes his narrative on the violence every now and then without any documentary proof. He dehumanizes the whole Kuki-Zo people as illegal immigrants, opium and drug dealers, but facts of matter speak otherwise. Official data does not conform to his narratives of the reason for waging war against the minority community.

Biren Singh’s character lies in the fact that he embodies a despicable blend of cunning deception and ruthless barbarity, masquerading behind a veneer of false tranquility while orchestrating merciless ethnic cleansings. He is a loathsome epitome of hypocrisy,



wielding power to show chaos, manipulate truths, and devastate lives without a shred of remorse.

It’s deeply troubling that despite the Kuki-Zos’ constant assertion that nobody is above the law, this narcissistic individual remains untouched by it. His direct involvement in the plight of the Kuki-Zo people raises alarming questions about justice. Is he immune to legal consequences or shielded from accountability, leaving him free while causing suffering?

DOCUMENTING MEITEI POLICE COMMANDO'S ATROCITIES ON INNOCENT CIVILIANS IN MOREH

After eight months of ethnic violence in the state, the Meitei Chief Minister, N.Biren Singh, declared on 6th January 2024 that a “war” had just begun in Moreh. According to him, the conflict had so far been between two communities, but now it is a “war”, supposedly referring to the increase of gunfights between the Village Volunteers (VV) and Meitei intruders – Police Commandos (CDOs), Armed Militias, and Valley Based Insurgent Groups (VBIGs).

Meanwhile, this strategically located town, an international border trade centre between India and Myanmar (Burma), is once again back in the news headlines as there has been exchange of gunfights between VV and Meitei intruders for two consecutive days, i.e., on 7th & 8th January 2024.

The continued violence involving atrocities committed by Meitei intruders against innocent civilians and heavy exchange of gunfire in this border town is not unexpected as it has been designed by intellectuals and defence strategists in a war room somewhere in Imphal. The ploy to create havoc in Moreh can be traced to a politically motivated development a decade ago.

Background:

Back in 2012, the Government of Manipur decided to open a Special CDO Unit in Moreh. Sensing the malicious policy of the communal government in

Imphal, the local populace opposed the decision as there was already a police station and enough Central Forces to handle law and order in the town. However, the state government somehow convinced some self-styled tribal elites and cleverly stationed the CDO Unit for what was supposed to be three months. Since then, the said “three months” has never ended, and there never was any good news coming from the CDO personnel either. For instance, there was a stand-off between the CDOs and 11 Assam Rifles in November 2015, and a bomb explosion in the Moreh police station in December 2016, to name a few.

Again, since the beginning of the current ethnic violence, several Kuki-Zo civil society organizations including ITLF, CoTU, Kuki Inpi Manipur, Kuki Inpi Tengnoupal (KIT), Kuki Inpi Chandel, and CSOs of Moreh have been demanding the removal of Meitei CDOs from this Kuki-Zo inhabited dominated town. Moreover, since the CDOs, who are always accompanied by Meitei militias including Arambai Tenggols and VBIGs, have been at the forefront in attacking and torching Kuki-Zo villages since day one, they were no longer seen as government security agency but part of the larger design to crush the Kuki-Zo community. The demand to

remove Meitei police personnel and CDOs from the Kuki-Zo areas was also corroborated by the declaration of “National War” by COCOMI and the Meitei CM himself.

Selected Incidents:

There have been innumerable incidents of gross violations of human rights committed by the said Special CDO Unit in Moreh in collusion with Meitei militias since the outbreak of the ongoing ethnic cleansing pogrom. Even before, there had been sporadic violence including murder of innocent civilians and tensions/stand-off with the central forces and public. For instance, an innocent and simple-living youth named Seiminthang Lupho (22) was killed on 28th April 2023, just a week before the violence began. The murderers were neither booked nor arrested! The public highly suspected the hands of armed Meitei militias or VBIGs who have always been hand-in-glove with the CDOs.

To substantiate the argument in favour of the demand for removal of Meitei CDOs from Moreh, few incidents are considered worth listing below:

1. On 3rd May 2023, the first day of the current ethnic violence itself, two innocent Kuki youths namely Mr. Thangminhao Haokip (18) and Mr. Thanggoulun Zou (16) were shot dead and eight others injured by Meitei CDOs. Later, one of them, namely Thanggoulen Lhouvum (16), succumbed to his injury in the hospital. This highhandedness of the police personnel resulted in the burning of some houses belonging to the Meitei community. However, since the Kukis were not aware of what transpired behind the outbreak of the violence, not even a single civilian was hurt. On the same night, i.e., around 11:30pm, an ambulance transporting the dead body of Mr. Jamkhopao Mate, accompanied by four members of his family, from JNIMS Hospital, Imphal, to Moreh was blocked and waylaid at Singjamei, where one of them was brutally lynched to death and the other three had narrow escape with the help of Assam Rifles but not before they sustained serious injury. Mrs. T. Mate, one of the survivors, said that a police CDO vehicle passed by with the personnel yelling, “Eikhoi Meitei ne” (meaning, “We are Meiteis”),

and drove away without helping us.

2. On 5th April 2023, around 8 am, three individuals namely Mr. Seikai Mate, Ms. Phakim Haokip and Mr. Ngamjang Haokip who came to pick-up their kids from schools were waylaid and beaten up by Meitei CDOs, but fortunately the Assam Rifles personnel on duty intervened and rescued them.

3. On 6th April 2023, around 8:10 pm, Meitei CDOs on duty set fire to an abandoned shop and blamed the local community who went to check the fire. The CDOs also fired in the air to scare them away.

4. On 7th April 2023, around 6:15pm, Meitei CDOs opened fire in a playground at New Moreh, and beat up a youth allegedly for violating curfew though it was well within curfew relaxation.

5. On 31st October 2023, following the assassination of SDPO Chingtham Anand Kumar by unknown miscreants, Meitei CDOs opened fire towards a group of women who were in a peaceful sit-in protest at Chikim Village. Many women sustained injury while fleeing for their lives.

6. On 1st November 2023, Meitei CDOs physically assaulted three women including a minor in the dead hours of the night on the pretext of conducting combing operations.

7. On 2nd November 2023, Meitei CDOs vandalised several vehicles and ransacked many houses at New Leikot village, D. Monnaphai village and several other places in Moreh. They also took away vehicles and properties without providing any reason.

8. On 29th November 2023, a peace agreement was reportedly signed between the Meitei extremist group UNLF (Pambei faction) and the Government of India. However, to the utter shock of the whole Kuki-Zo community, Moreh and Kwatha

in Tengnoupal district were chosen as two of the four proposed designated camps for these surrendered Meitei extremists. Since then, more and more Meitei youths from Moreh were seen donning CDOs uniforms thereby creating apprehension among the inhabitants of the town.

9. On 30th December 2023, the SP Railways & Incharge of Special CDO Unit, Mr. Th. Krishnatombi Singh, wrote to the ADGP(L/O) requesting requisition of a huge quantity of ammunition including explosives (bombs). On the same day, Mr. Peter Holkholal Mate, a school teacher by profession, was kidnapped, severely tortured, and was later left to die. However, he miraculously survives to narrate the ordeal. On the same day, at least three houses were also burnt down by Meitei CDOs. This resulted in a series of gunfights between the VV and Meitei intruders including CDOs.

10. On 2nd January 2024, two youths namely Mr. Lamminthang Lupho and Mr. Jamkholen Lupho were picked-up early in the morning, and were black and blue. When the womenfolk demanded for the safe release of the duo, the CDOs fired upon them. This reportedly angered the VV resulting in a heavy exchange of gunfight with these Meitei intruders. Later, the Assam Rifles rescued the two youths in critical conditions from the hands of Meitei CDOs.

11. On 8th January 2024, Kuki Women, who kept vigil in the town, detained a Meitei police officer dressed in Army combat uniform. The officer is none other than Col. (Retd.) Nectar Sanjenbam who was appointed as the Special Superintendent of Police (Combat), Tengnoupal district, a post specifically created for him by defying all established norms, by Biren's Cabinet to assist the Meitei militias and intruders whose sole purpose is to annihilate the Kuki-Zo. Soon after he was cornered by the womenfolk, Meitei intruders opened fire resulting in a series of gunfights. The Defence Wing of KIT, in a release, said that this Meitei officer came to the crowded Morning Market with the intention of carrying out a massacre on the Kuki-Zo community.

Concluding Remark:

Since the 3rd of May 2023, at least 158 innocent Kuki-Zo have been lynched/murdered and hundreds injured at the hands of the majority Meitei community. This includes 5(five) dead and at least 16(sixteen) injured from Moreh alone. In this border town, where almost all the police personnel and CDOs belong to the Meitei community, the Kuki-Zo people can't even file an FIR. In some cases where their FIRs were entertained, they are often assigned sections not directly related to, or deserving of the nature of the incidents. So, most of the victims are denied even minimum human rights including filing of FIR.

The above discussion, supported by the series of events mentioned, clearly shows that the current ethnic violence completes the geographical and emotional divide between the Meiteis and Kuki-Zo. It also shows that the whole ethnic violence is a well-planned attack orchestrated by the majority community with the open participation of the state government. The level of hatred the majority community has towards the minority Kuki-Zo was evident from the fact that even a dead body transported in an ambulance was not spared.

Therefore, as the KIT said in its memorandum submitted to the Union Home Minister, Shri Amit Shahji on 5th January 2024, and in many other such Memoranda and Press Communiqués issued by the Kuki-Zo CSOs, deporting Meitei CDOs and armed militias disguised as state police from Moreh, or replacing them with Kuki-Zo police personnel, is the only way out to restore peace and normalcy in this international border town. In fact, Moreh is the only hill town in Manipur where Meitei CDOs are posted, and unless the reason behind the state government's refusal to deport them to Imphal is to create mayhem, it can only mean a ploy to snatch the lands of the minority tribals by force.
