

MIZORAM: NO VOTING PLAN FOR DISPLACED KUKI-ZO From Manipur

As the nation prepares for the Lok Sabha elections next month, hundreds of Kuki-Zo people from Manipur who have been uprooted by ethnic violence and are seeking refuge in Mizoram may be unable to vote in the next elections.

A Mizoram election official said that currently no voting arrangement has been made for the Internally Displaced People (IDPs) from Manipur, who are currently taking shelter in Mizoram.

Election Commission Officials are discussing ways to help Manipuris displaced in various parts of the country vote in the upcoming Lok Sabha polls.

However, no written order has allowed them to vote from their host states, including Mizoram.

As per data from the Mizoram Home Department, 9,196 adults and children from Manipur have sought shelter in various parts of Mizoram.

Out of the 9,196 people, 1,340 are residing in 26 relief camps, while the remaining 7,856 are living outside the campus.

Meanwhile, Manipur will vote for two Lok Sabha seats in two phases, on April 19 and April 26.

The Manipuri people mainly, from the minority Kuki-Zo community have taken shelter in Mizoram. They have ethnic connections with the Mizos and have been living in the northeastern state since May last year after the ethnic violence erupted in Manipur.



Chief Election Commissioner Rajiv Kumar recently announced that the Election Commission has devised a plan to enable displaced individuals in Manipur to vote from their respective camps.

Manipur's Chief Electoral Officer (CEO), Pradeep Kumar Jha, told reporters that the voting scheme applies only within the state's borders. He also noted that no one has contacted them regarding the Manipuris sheltering in Mizoram.

The Indigenous Tribal Leaders Forum (ITLF) based in Churachandpur reported that Kuki-Zo people from Manipur are displaced not only in Mizoram but also in Delhi and various other cities across the country.

In previous instances, the Election Commission had permitted Internally Displaced Persons (IDPs) to vote from their host states.





PRINCIPAL, TEACHERS ARRESTED FOR LEAKING CLASS-X Science exam paper

The Cybercrime unit of Manipur Police arrested a principal of a school and his two assistant teachers in connection with the leaking and sharing of the Science question paper of the ongoing High School Leaving Certificate (HSLC) Examination 2024.


After producing them before the Chief Judicial Magistrate, Imphal West on Tuesday, all three were remanded into judicial custody till March 22, 2024, the police said on Wednesday.

Officials said the arrests were made under the Manipur Prevention of Malpractices in High School Leaving Certificate and Higher Secondary Examination Act 2024, IPC, and Cyber Crime Act.

This Act states, "Individuals involved in activities such as leaking question papers, whether in their custody or during transportation, printing, or evaluation, could face imprisonment ranging from five to ten years, along with hefty fines ranging from Rs 10 lakh to Rs 10 crore." At the court processes, it established that Mutum Bijen (61), the Principal of the Pishak Macha Bidya Mandir, Mayang Imphal, and his assistant teachers, namely Chirom Somendro (46) Chongtham Naoba (28) shared the science subject question paper on mobile Apps.

Later, the teachers shared the same on social media platforms a few hours before the commencement of the examination on March 15. The class 10 exams conducted by the Board of Secondary Education, Manipur (BOSEM) commenced on March 15, 2024.

It will continue till April 8, next month. 37,715 students appear in the examinations at 154 centres across the state.



This undermines the integrity of the examination process, compromises the fairness of assessment, and can confer unfair advantages to certain individuals, particularly students in the valley where the question paper was first leaked. Moreover, it has the potential to tarnish the reputation of educational institutions and diminish public trust in the examination system. When an examination paper is leaked, it typically necessitates either a re-examination or the cancellation of the affected paper. However, the Board of Secondary Examination Manipur (BOSEM) has yet to issue any statement addressing the matter or indicating any decisions made regarding the leaked question paper. Consequently, this situation has significantly damaged the image of BOSEM, raising doubts about their credibility as a governing body.







FOUR INTERNALLY DISPLACED CHILDREN DROWN **IN TUITHA RIVER**

Four internally displaced children died following an incident where they drowned in the Tuitha River in Churachandpur district on Wednesday.

The deceased have been identified as Thongkhohao (aged 6), son of Ngamginthang; Thanggouhao (aged 4), son of Thangminjang; Lallenchung Lupho (aged 6), son of Lunkholal; and Hathoithem (aged 9), daughter of Lunkholal.

Yesterday, the four children went to bathe at the bank of the Tuitha River. However, as they failed to return at the ECA Relief Centre in Cannan Veng, until late evening, various Civil Society Organizations (CSOs) initiated a massive search operation to locate them. After an extensive search, the bodies of the missing children were recovered early this morning from the Tuitha River.

Following post-mortem examinations, a condolence program for the deceased was held at the KKL Complex, after which they were laid to rest at the KKL Cemetery this afternoon.

NAGA COUNCIL CONDEMNS AR'S ALLEGED FIRING ON CIVILIANS

The United Naga Council (UNC) expressed deep concern over a recent incident involving what it termed as "belligerent provocation" by the 6th Assam Rifles, alleging indiscriminate firing of live bullets on Naga civilians, particularly women, at Chingkao (Makuai) village in Tamenglong district on March 14. In a statement released today, the UNC vehemently condemned the actions of the Assam Rifles, stating that such acts disrupted the peaceful atmosphere in the area.

The UNC accused the Indian security forces, under the patronization of the government of India, of waging what it described as an "undeclared war" against the Naga people for decades, citing the draconian law of AFSPA, 1958. Describing it as one of the "cruelest crimes" committed by India before the world, the UNC asserted its condemnation of the alleged military

campaigns and violence perpetrated against the Naga populace.

Expressing disappointment with the lack of progress in resolving the political issue between the Naga people and the government of India, the UNC highlighted the continued violence and betrayal by the government. Despite hopes for change with changes in leadership, the UNC lamented the persistence of wanton killings, military campaigns, and betrayal, terming it "truly disheartening."

The UNC drew attention to the prevailing situation in Manipur, noting ongoing violence, killings, extortions, and intimidations within the state. It pointed out the relative peace observed only in Naga villages amidst the turmoil. Source: East Mojo





MEITEIS TO OPPOSE ELECTION CAMPAIGN FOR OUTER MANIPUR IF ANSAM DOES NOT RETRACT ITS OPPOSITION TO MEITEIS' ST DEMAND

A newly formed Meitei civil body called "No ST No Vote Campaign Committee, Thoubal and Kakching Districts" has declared that they would not allow and support any election campaign for the Outer Manipur Parliamentary Constituency in Thoubal and Kakching districts if the All Naga Students' Association Manipur (ANSAM) does not withdraw its opposition to the Meiteis' ST status demand.

Briefing the media at Kakching, the President of "No ST No Vote Campaign Committee, Thoubal and Kakching districts," P. Budhi demanded that all the candidates in the Outer MP constituency must include the demand for inclusion of Meitei/Meeitei in the ST list in their election manifesto.

Budhi said, "No other community in Manipur has the right to oppose the Meiteis' demand for inclusion in the ST list. Neither ANSAM nor the state government has the authority to grant ST status to the Meiteis but



the sole authority lies in the hand of the Indian government."

The Outer Manipur Parliamentary constituency is reserved for Scheduled Tribes of Manipur, and the areas of all the hill districts including some areas of the valley dominated by OBC Meiteis in Kakching and Thoubal.

NO NOMINATIONS FILED FOR TWO LOK SABHA SEATS ON FIRST DAY

Election notification for both the Lok Sabha seats in Manipur was issued on Wednesday, an official said.

The seats are 1-Inner Manipur Parliamentary Constituency and 2-Inner Manipur Parliamentary Constituency.

While Inner Manipur covering 32 assembly segments will go to polls on April 19, Outer Manipur having 28 assembly segments will vote on April 26.

No nomination was filed on the first day, the official said.

Meanwhile, poll preparedness has started in full swing at the district election office in Imphal West with various



district committees actively engaging in electionrelated activities, officials said.

The deadline for filing nominations is March 27, with scrutiny of papers scheduled for March 28, and the last date for withdrawal of candidature is March 30, according to a notice by the returning officer. (Source: India Today NE)





CONTINUED MEITEI ATROCITIES: MUSLIM PANGAL VICTIM Succumbs to injuries from meitei radicals' assault

In the latest case of Meitei atrocities against minorities in Manipur, a Muslim-Pangal identified as Mayajul Laskar from Jiribam district succumbed to injuries after he was brutally tortured by Meitei radicals on March 19.

In connection with the incident, the JAC against Brutal Killing of Mayajul Laskar is fervently demanding justice following the tragic murder of Mayajul, which occurred yesterday.

Foiz Ahmed, the Convenor of JAC, addressed the media, stating that on March 19th, around 8:00 am, Mutum Biken from Gularthol, accompanied by others, visited Mayajul Laskar's residence in Babupara Ward No. 5.

Foiz Ahmed recounted that Mayajul was taken from his home under the guise of a cattle sale. Tragically, it was later revealed that he had been subjected to brutal assault and succumbed to his injuries.

The JAC has promptly submitted a memorandum to the Deputy Commissioner of Jiribam, as well as to the Chief Minister of Manipur and the local MLA, urging the swift apprehension of those responsible for Mayajul Laskar's murder.

Additionally, they are calling for a comprehensive investigation into the case. The JAC Against Brutal Killing of Mayajul Laskar cautioned that failure to address the matter expediently could lead to unrest in the area. They emphasized the potential for mass protests and rallies if justice is not swiftly served.

The Muslims and Nagas have been subjected to severe brutality by the Meiteis in what appears to be statesponsored ethnic cleansing, despite their neutral stance.

n January 1st of this year, a tragic incident occurred in Lilong, Thoubal district, where four local Muslims



were killed and 14 others injured. Curfews were imposed in all six valley districts at the time. A group affiliated with Arambai Tenggol, a powerful armed militia organization aligned with the Meitei Sanamahi religion, entered a home in Lilong to demand ransom money. It's reported that they had previously demanded Rs. 50 lakh from a resident, who had already paid Rs. 17 lakh. When the family refused to pay the remaining amount, the group resorted to force on New Year's Day, resulting in a violent altercation.

The heavily armed militia proceeded to ransack the house, destroying furniture and firing at family members at close range, resulting in the deaths of four individuals. Local residents, upon hearing the commotion, intervened, leading to further clashes in which approximately 14 people were injured. Some militia members were apprehended by the angry mob and handed over to the Manipur police.

The Muslims have faced repeated oppression at the hands of the Meitei majority, with instances of Muslim businessmen being assaulted and their goods destroyed while conducting trade with Kuki-dominated districts.





NPF NAMES KACHUI TIMOTHY ZIMIK AS CANDIDATE FOR OUTER Manipur lok sabha seat

The Naga People's Front (NPF) has officially endorsed Kachui Timothy Zimik as the party's designated candidate for the Outer Manipur parliamentary constituency in the upcoming Lok Sabha elections 2024.

The NPF's ticket distribution ceremony for the Outer Manipur parliamentary constituency is scheduled to take place on Thursday (March 21) at the party's central office in Kohima, Nagaland.

Zimik, a retired Indian Revenue Service (IRS) officer, previously served as the principal chief commissioner of income tax in the union ministry of finance (revenue).

Notably, the CPI has named Laishram Sotinkumar Singh as its candidate in the Inner Manipur Parliamentary Constituency.

A resident of the Khurai area in Imphal East district, Sotinkumar is the Manipur unit general secretary of the All India Trade Union Congress (AITUC) and former state secretary of the party.

The Congress and BJP have yet to finalize their candidates for the Inner Manipur Parliamentary seat. Reports suggest that the BJP is pressuring CM N. Biren Singh to contest the Lok Sabha polls from Inner Manipur, while the Congress is considering Prof. Angomcha Bimol Akoijam for the same position.



On the other hand, the Congress has announced its candidate for the Outer Manipur Parliamentary Constituency as former MLA Alfred Kanngam Arthur, who has already begun his campaign a few days ago.

Manipur comprises two Lok Sabha constituencies: the Inner Manipur constituency, encompassing the Meitei-majority valley areas, and the Outer Manipur constituency, designated for Scheduled Tribes (ST).

The Lok Sabha elections in Manipur will be conducted in two phases, with the Inner Manipur seat scheduled for polling on April 19, while voters in the Outer Manipur constituency will cast their votes on April 19 and 26.

MEITEIS LOSE SENSE OF REASONING, HUMANITY; TRY TO CELEBRATE TRAGEDY OF FOUR KUKI CHILDREN DROWNING IN RIVER

The Meiteis in their Kangleipak have lost their sense of reasoning and humanity since the outbreak of their ethnic cleansing pogrom on the Kukis, uttering several unreasonable statements of hatred against a particular community even in humanitarian issues.

No doubt, the Meities often blame the Kukis for every happening without giving any substance out of it. Even after all the Kukis were evacuated from their ancestral land of Imphal valley, most of the Meiteis still point fingers at Kukis for any wrong incidents happening in Imphal. For instance, the Meiteis on their social media platforms used to blame the Kukis for torching the houses of Kukis in New Lambulane in Imphal even though the Kukis have abandoned the places owing to the conflict.

Today, four children belonging to the Kuki community who were sheltering in a relief camp in Lamka lost their precious lives after drowning in the river. However, the Meiteis, while using the social media platforms have mocked by alleging that the children have lost their lives while their parents were out of home in their quest to attack or kill the Meiteis, which is baseless and unfounded.

One Meitei social media page uploaded a post and a photo of the 4 deceased children with a caption, "Amidst the time when their parents tried to attack the Meiteis, their children have died."

The Meiteis have blatantly ignored the fact that the four children and their parents have no option but to stay in relief camps after the Arambai Tenggol and the Meitei militants attacked their villages, and were forced to stay in relief camps in Churachandpur.

The children were from the other hill districts and they were compelled to stay in relief camps in Churachandpur



as a result of the conflict. Had the incident occurred in the valley, the Meiteis would have resorted to protesting, blaming the government for the incident and even would have asked for compensation.

The four internally displaced children died drowning in the Tuitha river while they were taking a bath on Wednesday. As the news spread, the Meiteis resorted to a celebrating mode over the tragedy, losing any sense of reasoning and humanity.

But, even though we haven't done anything wrong, we are now paying the price of this war.

Yes, we deeply miss our village, our homes, the water, the trees, the animals, and everything. We miss playing in the water. At last, we decided to once again feel our homes and the environment by visiting and playing in the river. We just want to feel the water/river because it reminds us of our homes. We never thought that our 'missing of home and playing in the river' would result in our loved ones like you all missing us from this earth.

Since the night of 19th March 2024, we became the talk of the town. And many of you searched for us throughout the long night, but in vain! Sorry for making you all tired and weary throughout. But we were just kids who wanted to live as kids, and we went to the riverside to play. Neither did we realize that it would be the last time we ever touched water. The next morning, the search for us continued, and there we were, all lifeless forms. The hoarded worries since yesterday night now turn to cries and screams. Sorry! We never imagined making you all sad.

We were just kids who wanted to live as kids. We wanted to build castles from wet mud and clay along the riverbanks, skip stones, splash and sprinkle water on each other, bathe and scrub off dirt with small river stones. As we played and bathed, we also had fun in tickling each other and taking turns on scrubbing each other's back.

We would hide our friends' clothes, and when they finished bathing, they would search for them with puzzled looks while we giggled. These were some of the simple pleasures we cherished as children, and for once, we tried living as we were meant to be. And then, we were gone, gone from this earth. For this world has no place for kids like us to live as kids.

Oh, river! Have you, too, turned as cruel as some humans? We came to play by your side, innocent and full of joy, but you snatched us away. Now, mama, papa, grandma, grandpa, sisters, brothers, and everyone we loved is left in tears.

Oh God, didn't you know that we were your innocent children? So young that when all four of our ages were tallied, we only reached 25 years together. Besides, we were internally displaced persons (IDPs), living in a relief camp. Our fathers and brothers are on the frontline, while our mothers and grandmas toil so hard, earning whatever they can on a daily basis. Even though we were small, we were the only hope of our parents. After enduring whatever hardships, we became their last string of hope, and now you've cut us off from them. Our loved ones are left with nothing but despair.

And now, we, The Four talk among ourselves:

If there were no war, we would still be playing in the village streets, laughing and leaving our marks along the riverbank. We would come home dirty but happy, sharing stories of our day. But war stole our childhood, our joy, leaving only silence and taking our memories and lives in its wake.

Goodbye Mama, Papa, Grandma, Siblings... And all those who loved us.
