MEITEI CENTRIC MANIPUR GOVT AVERSE TO DEVELOPMENTAL WORKS; KUKI CHIEFS' ASSOCIATION RAISES CONCERN

The state sponsored ethnic cleansing against the Kukis in Manipur has now reached its tenth month. During this violent conflict, all lifelines essential for the well-being of the Kuki community has been abruptly cut-off.

The Kukis, unlike the Meiteis, have inhabited various hill districts which make it hard for them to communicate during these hard times. The violent conflict often disrupts communication networks, making it difficult for people to stay in touch with their loved ones, access vital information, or seek help in emergencies.

The state sponsored violence rendered transportation infrastructure unusable, cutting off access to essential goods, services, and resources. Roads may become unsafe due to conflict-related dangers such as checkpoints, roadblocks, or attacks on vehicles. Connecting one district to another district has become a daunting task.

In summary, violence during war cuts off essential lifelines by disrupting communication, transportation, healthcare, food security, shelter, livelihoods, and psychosocial well-being. Addressing these challenges requires concerted efforts to protect civilians, uphold humanitarian principles, and facilitate access to lifesaving assistance in conflict-affected areas.

Keeping in mind the importance of connectivity, the locals of Gunpi area in Chandel district tried to construct a temporary bridge over the Imphal river between K. Molnom and Khawlmual village in order to facilitate better connectivity services between the two districts – Chandel and Churachandpur.

However, the proposed developmental work has been opposed by the Meitei centric Manipur government in the form of a Directive issued by the Deputy Commissioner of Chandel.

Chandel DC Mayanglambam Rajkumar has directed all concerned that such preparation for construction



of a bridge in/near the security sensitive zone without the authorization of competent authority shall be immediately stopped. Law enforcement agencies including the Assam Rifles, in aid of Civil Authority, shall stop such illegal construction. He further warned that appropriate legal action will be taken against those who disobey the compliance of his direction. In regards to this, the Kuki Chief Association Gunpi Area (KCAGA) has written to the local MLA SS Olish requesting her for cancellation of the directives of Deputy Commissioner Chandel, Direction Vide No. 3/Home/3(2)-L&O/DC (CDL) dated Chandel, 21st March, 2024.

The Chief Association argued that since the outbreak of state sponsored ethnic cleansing in Manipur all the life-lines of Kukis in Manipur have been abruptly cut-off. The general public has no other option/alternative other than constructing the bridge over the said river between the aforementioned villages, which are about 5 km from the security sensitive zones as claimed by the Deputy Commissioner, Chandel.

The association reminded the local MLA that they submitted a memorandum to her good office

regarding construction of a Kaccha Bridge in public interest and that they are still waiting for her positive response till now.

In fact, considering the urgency of accomplishing the work before the setting in of monsoon, the KCAGA have already started the work with humble assistance they could mobilize voluntarily. However, to their dismay the Deputy Commissioner, Chandel issued the direction restricting all forms of works related with the construction of the bridge stating that the proposed bridge is close to the security sensitive zone of Sugnu/Serou area.

The Chief Association however clarified that K. Molnom is actually not an affected village and it lies beyond the said sensitive zone as such the KCAGA could have taken up the said works with the support of all concerned civil society organisations of the community. There is no question of possible unrest and adverse security situation for constructing the said bridge which is the only viable means for survival of the area public in terms of transporting daily essential commodities for the war victims and the displaced ones. The construction is recommended and supported by all the civil society organisation/CSOs of the area in the interest and welfare of the displaced war victims of Gunpi Area, Chakpikarong, Sub-Division, Chandel district, Manipur in line with DC/CDL order vide no. 3//HOME/3(2) L&O/DC/(CDL) GOMoffice of the DC, CDLDt. 2nd November 2023 and others.

“Regarding the adverse security situation as pointed out by your esteemed office there is no room for adverse security apprehension as enough central para-military forces and state forces are posted at many places on both sides of the Imphal river (Chandel & Churachandpur). To be specific security personnel are posted at UkonThingkangphai, Senam Thingkangphai, L. Thinglhangphai, Y. Thingkangphai, Chakpi Molbem and V. Haipijang from Chandel district side and from Churachandpur district at New Bijang, Khaokawl and Zalenkot. The exact location of the work site is far away from the so called sensitive zone and therefore there would not be Law and Order problems in the location as alleged by the concerned civil administration of the

district. Under the aforementioned circumstances it is requested that your esteemed office appreciate the samaritan works taken up by the CSOs of the area for alleviation of the hardships being faced by the war victims and displaced persons currently by withdrawing DC/CDL order of the 21st March, 2024 on humanitarian ground, otherwise it tantamount to human rights violation.”, the statement reads.

The public in the area has resented the DC directive which ordered the cancellation of constructing a temporary bridge as this proposed bridge is going to be constructed purely from public donation. The DC Chandel has been oppressive to the war displaced people of this area. He did not even recognize the Relief Camps set-up in the area, sidelining the people of the area and blatantly ignoring their hardship.

The DC directive is inhumane as the proposed bridge is going to be constructed between Bijang Police Outpost and Khaukual IRB post and the distance between the two villages is not even half kilometer. The bridge is supposed to be only for light vehicles.

If this conflict has taught us anything, it is that connectivity is absolutely necessary—for communities in the two districts and Manipur. For those who have access, connectivity is considered a tool for surviving a conflict. However, depriving people of this facility itself is a crime as the bridge will serve as a connecting link between the same communities from different districts.

It is the duty of the government to construct and facilitate transport facilities for the deprived people. Yet, on the contrary it is the government who tries to disrupt the only viable option the local people have envisaged for better transport facilities. This indeed once again solidifies the accusation leveled against the Manipur state government of engineering state sponsored ethnic cleansing against the Kukis.

SUSPECTED CADRES OF ARAMBAI TENGGOL, UNLF(P) ABDUCT A MEITEI PANGAL INDIVIDUAL IN PUBLIC, FORCE HIM TO MAKE UNVERIFIED STATEMENTS

In a glaring example of the absence of law and order in the valley, suspected members of Arambai Tenggol and UNLF(P), dressed in full combat uniform along with sophisticated weapons, have abducted one Meitei-Pangal (Muslim) from a crowded place in Thoubal on Friday evening.

Sources said the abducted was intimidated by the militants and forced to vilify former police officer, Th. Brinda.

The incident happened at around 6.30 PM in the evening at Moijing under Thoubal district. The act was recorded in a CCTV camera installed near the site of the incident.

As seen in the footage, suspected Arambai and UNLF cadres came in a black XUV and a few others in cars. They stopped and parked their vehicles on the busy road and then forced the Meitei Pangal man to come out of the car he was driving. The Muslim man, identified as Md. Abbas Ahemad, was seen carrying a kid as he came out of his car. As soon as Abbas came out of his car, the suspected Arambai and UNLF members surrounded him, snatched the kid and left the kid in a shop nearby. Thereafter, Abbas was put inside one of their cars and was taken away.

Though there were many people present at the site of the incident, they could only remain as silent observers since the suspected Arambai Tenggol and UNLF militants were holding sophisticated weapons.

Later, another video surfaced on social media platforms wherein Md. Abbas was seen intimidated and forced to say that he along with Thounaojam Brinda, former police officer, had taken up many anti-social activities wherein they had even put innocent people in trouble.



It was learnt the Thoubal police rescued Abbas from Mayang Imphal - Thoubal Moijing IV road and was handed over to the family.

The incident indicates the absence of law and order in the valley and it shows how the Meitei UGs or the Arambai Tenggol are given a free hand in taking up any activity they wish in the valley. It also proves that the Meitei militants and radical groups no longer fear the State police and they consider themselves to be above the State forces.

COMBINED SECURITY FORCES ARREST PROSCRIBED KCP (PWG) MILITANTS; PROTEST ERUPTED

In an operation, the combined security forces have arrested 13 proscribed militant cadres of Kangleipak Communist Party, People's War Group (KCP-PWG), including three women, on Saturday morning at Kameng Sabal and Loitang Sandum area of Imphal West district. The forces also rescued one individual who was in the custody of the outfit.

Even if police sources have said that those arrested were cadres of banned Meitei armed group KCP, the Meitei women group would claim them as "Village Volunteers."

According to the Police, a combined security force, led by state police personnel, descended upon the Mayang Langjing Tamang Kameng Sabal area around 2:30 am today. The security team apprehended 14 individuals belonging to the proscribed KCP (PWG) group. Those cadres were involved in prejudicial activities at their camp including training of new recruits, kidnapping, extortion, etc.

The arrested cadres were identified as Sagolsem James (26), Khumbongmayum Ranjan (24), Ningthoukhongjam Robichand (26), Ningthoukhongjam Sushil (48), Moirangthem Mohen @ Manao @ Pari (40), Thokchom Micheal (25), Seram Athem (27), Khulem Bidur (51), Kangabam Abungo (21), Yumlembam Inao (43), Ningthoujam, Ranjeeta (20), Salam Binita (20) and Thokchom Sumati (29).

As usual, the Meitei women began to protest over the militants' arrest, demanding their safe release. Tension erupted in the area between security forces and the Meira Paibis when a group of women attempted to thwart the security forces from arresting the 14 Meitei militants. However, they were dispersed by



the police using tear gas shells. The security forces even resorted to blank fires into the air to push back the approaching protesters.

Following the operation, the security forces recovered a cache of weapons and ammunition, including 5 carbines, 1 AK-47 rifle, 2 .303 rifles, 1 INSAS rifle, 2 9mm pistols, and 1 double barrel shotgun, along with ammunition. Additionally, several vehicles utilized by the militants were seized, including 1 Vespa scooter, 1 Activa scooter, 1 Chevrolet Beat car, 1 Mahindra Bolero, 2 Maruti Gypsy vehicles, and 1 Tata Safari SUV.

Notably, the Meiteis' valley of Imphal has become a safe heaven for the proscribed Meitei militants for carrying out their illegal and anti-national activities. The banned Meitei outfits including UNLF/MPLA, KCP factions, PLA/PLO, KYKL, PREPAK, etc., have been actively involved in "trans-national conspiracy against the Union of India." Since the state-sponsored ethnic cleansing pogrom on Kukis broke out on May 3 last year, the Meitei terrorists have been crossing the international border from Myanmar and are actively engaging in war against innocent Kukis in Manipur.

ELECTION MOOD ACTIVATED IN NAGA AREAS; ZUF CONDEMNS GUN ATTACK ON CONGRESS CANDIDATE

With the 18th Lok Sabha election round the corner, political tensions loom large in the state amidst unending violence, the state has already witnessed election related violence in the past few days.

The announcement of candidates for Outer Manipur Parliamentary Constituency has invoked election mood in the minds of the people. However, the BJP who announced support to NPF candidate in Outer Manipur is yet to announce their candidate for the Inner Manipur PC. The Congress supported by INDIA Bloc has formally announced JNU Professor Dr. Bimol Akoijam as its consensus candidate for Inner Manipur while former Legislator Alfred K. Arthur has been chosen for Outer Manipur PC.

Before the official announcement of his candidature by his party, Alfred K. Arthur kickstarted his electoral campaign in Ukhrul and Kamjong district a few weeks ago. His public meeting was attacked with gunshots by armed miscreants, signaling their disapproval of his candidature.

It is common knowledge for keen observers of Manipur electoral politics that NPF is the political wing of NSCN-IM who commands majority in Naga dominated areas of Manipur. As such, the candidature of Alfred K. Arthur from Congress did not bode well with the idea of Naga national leaders. That the NPF candidate is the de-facto NSCN-IM candidate for LS poll – is an open secret known to all.

Amidst all this, the Zelianrong United Front (ZUF) issued a statement today condemning any form of violence or disturbance during the campaign period, particularly highlighting recent incidents, such as the gunfire at a Congress party meeting in Ukhrul District. The involvement of certain groups, like the NSCN-IM,



is also condemned and cited as a threat to the democratic process.

In a statement, the Front stressed the importance of selecting leaders who will prioritize justice, peace, and overall development. It warned against the influence of corrupt practices and manipulative politics, urging strict adherence to the principles of the National Union of India.

Expressing concern over the interference of Naga revolutionary groups in Indian politics, the Front warned of dire consequences for the Naga people if such actions persist. It called for greater accountability from Indian security forces in maintaining public safety and preventing further destabilization. Emphasizing the importance of free and fair elections, the Front called on all citizens to uphold this democratic mandate. It reaffirmed its commitment to serving the common interests and welfare of the people, pledging to ensure a peaceful and equitable electoral environment.

The Front urged citizens to support efforts towards a better society and the election of leaders who will secure peace and prosperity for future generations.

BJP PARTY OFFICE VANDALIZED IN MANIPUR'S SENAPATI DISTRICT

In response to the non-issuance of a party ticket to a local candidate, Senapati District BJP Karyakartas vandalized their office located on Old Road, Senapati. The incident reportedly occurred around 10:30 am on Saturday morning. The exact identity of the perpetrators could not be ascertained as there were no surveillance cameras or eyewitnesses.

The motive behind the vandalism appears to be targeted destruction rather than theft, as valuable assets were left untouched. Possible motives include protest against the decision to support another party's candidate for the forthcoming election. The vandalism has disrupted normal office operations, causing delays in workflow



and financial losses due to the need for repairs and replacements. Morale among the karyakartas has also been negatively affected by the incident.

TWO HELICOPTERS DEPLOYED FOR MANIPUR LS POLLS, SAYS CHIEF ELECTORAL OFFICER

Two helicopter Rapid Response Teams (RRTs) are being pressed into services to ensure the integrity of the electoral process in the violence-hit Manipur, the Chief Electoral Officer of Manipur, Pradip Kumar Jha said.

He was speaking in a meeting held on Saturday with Chief Medical Officers (CMOs) of various districts at the Conference hall of the Office of the Chief Electoral Officer of Manipur. Manipur with its two Lok Sabha seats — Outer Manipur Parliamentary Constitution reserved for scheduled tribes and Inner Manipur PC will go to the polls on April 19 and 26.

Approximately 200 companies of paramilitary forces will be deployed in the sensitive areas of the state for the upcoming Lok Sabha elections.

NDA REGIME SHOULD BE PUT IN CHECK, SAYS MNF'S LOK SABHA CANDIDATE K VANLALVENA

Mizoram's main opposition Mizo National Front (MNF) on Friday named sitting Rajya Sabha member K. Vanlalvena as the party's nominee for the lone Lok Sabha seat, polling of which is scheduled on April 19.

Vanlalvena, 54, was elected to the lone Rajya Sabha seat in Mizoram in June 2020.

MNF president and former chief minister Zoramthanga declared Vanlalvena as the party's candidate during a function held at the MNF office-Mizo Hnam Run, in Aizawl.

Speaking on the occasion, Vanlalvena on Friday said that the BJP led NDA regime should be put in check and fought back vociferously.

The Mizoram MP, who remains vocal in issues related to minorities, also said that he constantly opposes NDA ideologies in the present Rajya Sabha.

Interestingly, MNF is a member of BJP led North East Democratic Alliance (NEDA) and an ally of the NDA at the Centre. But the party doesn't work with the saffron party in the state.

Vanlalvena said that the NDA will retain power in the forthcoming parliamentary polls.

He said that the NDA, if retained power, will apparently introduce Uniform Civil Code (UCC) in the country for which the NDA government should be opposed vociferously.

"It appears that the NDA will retain power at the Centre after the Lok Sabha polls. If it retains power there is the likelihood that the UCC will be introduced in the country. For this reason, the NDA government should be opposed and fought back vociferously. I have been constantly opposing the NDA government in the present Rajya Sabha," the 54-year-old MNF leader said.

He said that Mizoram MP alone has no significant role in the formation of government at the Centre as the



fight is confined mainly between two broad blocs—the NDA and the Indian National Developmental Inclusive Alliance (INDIA).

Citing that language barrier did not bar him from raising issues in the parliament, Vanlalvena said what matters most for being an MP is the mind or the courage and not simply having a good command over Hindi and English languages.

The former student leader remained vocal in important issues pertaining to Mizoram and minorities in the country. His audacity to raise important issues in the parliament has been lauded by many.

Vanlalvena worked as a teacher in a government-run high school in 1995 two years after he graduated with science from Pachhunga University College (PUC) in Aizawl in 1993. But his teaching profession lasted for only three months as he was elected as the president of state's apex student body, Mizo Zirlai Pawl (MZP). Recently, he obtained a master degree in history from Indira Gandhi National Open University (IGNOU) more than 30 years after he left college.

He was imprisoned on 8 occasions during his tenure as student leader. Vanlalvena entered politics in 2002 when he was appointed the general secretary of the MNF's youth wing. He subsequently became its president. (Source: NE Now)

SWOT ANALYSIS: ETHNIC STRIFE TO AFFECT BJP'S CHANCES IN MANIPUR FOR LOK SABHA ELECTION

The popularity the BJP had seen in 2022 when it won 32 seats in the 60-member assembly has been sliding after ethnic violence between Meitei and Kuki communities broke out in the state on May 3 last year, leading to the death of over 200 people.

As the strife hit national headlines, especially after a video of two women being paraded naked surfaced, the BJP-led government at the Centre have taken several measures seeking to bring back people's confidence in the administration.

The Centre has announced erecting fencing on the Indo-Myanmar border and cancellation of the Free Movement Regime (FMR) to address the issue of illegal immigration from the neighbouring country.

The steps may have some positive electoral effects for the BJP in the Inner Manipur Lok Sabha constituency comprising assembly segments of the Imphal valley.

These measures are likely to adversely affect the saffron camp in the other seat of the northeastern state, Outer Manipur, which covers the hill districts, home to Naga and Kuki community people who are against those moves by the BJP government.

The opposition Congress, which lost power in the state in 2017, is also not on a strong pitch as it has been plagued with internal bickering over selection of party candidates. Rajiv Gandhi's visit after the ethnic strife began, however, might help the party in the elections.

Inner and Outer Manipur seats are held by the BJP and Naga People's Front (NPF) respectively.

The elections will be held in the state in two phases on April 19 and 26.

Following is a SWOT (Strengths, weaknesses, opportunities, threats) analysis of the BJP and Congress in the state.

Strengths

*Cancellation of FMR and announcement for erecting

border Fencing by the BJP government are points to appeal to the voters of Inner Manipur seat.

*Distribution of monetary compensation for more than 3000 farmers affected by violence both in the hills and valley districts will help the BJP.

*The government's "inability" to protect lives and properties of the people is likely to help the Congress.

*Congress will also highlight Rahul Gandhi's two-day visit to the state weeks after the violence broke out. He also began his Bharat Jodo Nyay Yatra from the state this year.

Weakness

*BJP MP faced criticism from different quarters for not being vocal in Parliament and at the national level over the violence in the state.

*The BJP government's inability to establish permanent peace even though 10 months have passed after the violence began.

*The Suspension of Operations agreement with Kuki militant organizations was signed in 2008 when Congress ruled the state. A section of the people wants the pact to be discontinued.

*The Congress is facing allegations that it did not effectively tackle the border issues as the BJP has claimed illegal immigration from Myanmar is the root cause of the ethnic violence.

Opportunities

*BJP's opportunity is the absence of a strong and popular candidate in Congress.

*Congress will highlight the inability of the BJP to protect people's lives and property during the ethnic strife.

Threats

*Any fresh violence or steps taken against village volunteers by security forces would hit the BJP hard.

*Infighting in the Congress about the selection of candidates.

India's 'Act East' Policy Compels It to Look at Manipur

Indian foreign minister S. Jaishankar's recent remarks on the situation in riot-hit Manipur state while addressing the Indian community in the South Korean capital Seoul must be understood from political as well as geo-strategic perspectives.

"Distressing is a very mild word ... for what is happening in Manipur," he told the Indian diaspora on March 5. It's been 10 months since the violence began in the northeastern state bordering crisis-ridden Myanmar. Officially 219 people have been killed so far, most of them Christians.

The pro-Hindu Bharatiya Janata Party (BJP) government in the state has dubbed it an ethnic conflict, but Christian leaders have accused it of siding with the majority Hindu Meitei community which is at odds with the tribal Christian Kuki-Zo people.

"In terms of ... how did this happen? How did the government let this happen? You know there cannot be anybody who would not regret what is happening there," the foreign minister said.

He sounded critical of the BJP government in Manipur. But Jaishankar is a member of the same party and a federal minister who has Prime Minister Narendra Modi's ears.

Manipur was one of multiple questions about India

raised by the diaspora, and, in all probability, Jaishankar had the nod from the Prime Minister's Office for making those remarks.

Before coming to Manipur, the minister dwelt on how the Modi government brought the mere talk about "Look East and Act East" — first devised in 1991 — into actual practice and implemented several projects that benefit the entire northeast region.

"If you look at how difficult it was to travel, if you see the sort of level of business, the attention given, the resources given, it [the Manipur riot] was actually very disturbing. And that has been one of the changes of the last 10 years," he asserted.

He then stressed how he felt that "in many respects, the northeast itself can act as a bridge, but it has both a cultural side to it and a physical contiguity side too."

His explanation of what happened there was "the close intermingling of communities" leading to "this degree of violence, which becomes very difficult to head off."

The foreign minister was well aware that Korea has a substantial Christian population and the

ethnic conflict in Manipur could draw criticism of the BJP governments in both New Delhi and in Manipur.

Tribal Christians, including Nagas and Kukis, form around 41 percent of Manipur's 3.6 million people. They primarily inhabit the hill districts.

The Meiteis make up some 53 percent of the population and reside in the Imphal Valley.

And then there are about 6,000 refugees from Myanmar taking shelter in the state.

Analyst Ashutosh Talukdar, who is based in the northeastern state of Assam, observed that a foreign minister "would avoid making any remark on internal or domestic matters, leave aside a disturbing situation, on foreign soil."

But Jaishankar could not have avoided northeast India as it is a bridge to neighboring countries such as Myanmar and other Southeast and East Asian countries.

New Delhi is well aware that violence and instability in Manipur can harm its long-term strategic interests and derail the "Look East and Act East" policy.

The minister's remarks thus have to be viewed through this perspective.

The situation in Manipur has not only embarrassed Modi and the BJP but may also derail the progress achieved since 2014, when Modi became prime minister, in developing economic cooperation and strategic relationships with countries in the wider Indo-Pacific region.

The Modi dispensation is keen on moving forward at bilateral, regional, and multilateral levels to enhance political, economic, cultural and people-to-people relations in the region.

Modi's critics point out that for four months after the riot broke out on May 3 last year, he did not utter a word and broke his silence only in August after a video went viral on social media showing two Christian Kuki

women being sexually assaulted and paraded naked in the streets of Manipur.

Federal Home Minister Amit Shah told the Indian Parliament on Aug. 9 that, "people crossing over from Myanmar" were responsible for the distressing situation in the state.

Even Jaishankar echoed him when he said that the open border with Myanmar was one of the issues. "We have decided now to suspend that [open border] and, actually, in a way, harden the border situation," he explained.

The bilateral Free Movement Regime allowed people from India and Myanmar to travel up to 16 kilometers into each others' territory without travel documents. That will stop now.

But Jaishankar's utterances in Korea must also be seen as a late application of balm on the festering wounds of Manipur, ahead of a general election this summer.

Modi is seeking a third term as prime minister and Manipur remains a weak spot for him.

The prime minister avoided campaigning in neighboring Mizoram during the state election in November-December 2023. But can he afford to skip the northeastern states now?

We "would like to see law and order return," Jaishankar said while adding, "This is not the India, and certainly not the northeast, which anybody is hoping for."

His comments could also be meant to pave the way for Modi's long-delayed visit to Manipur.

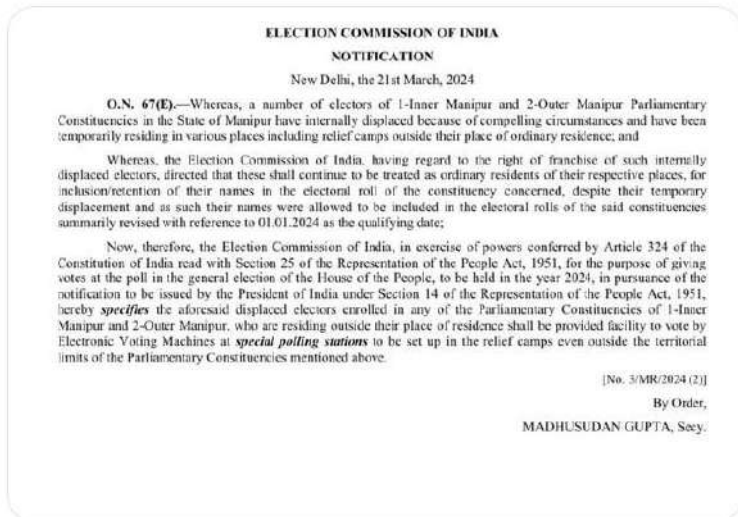

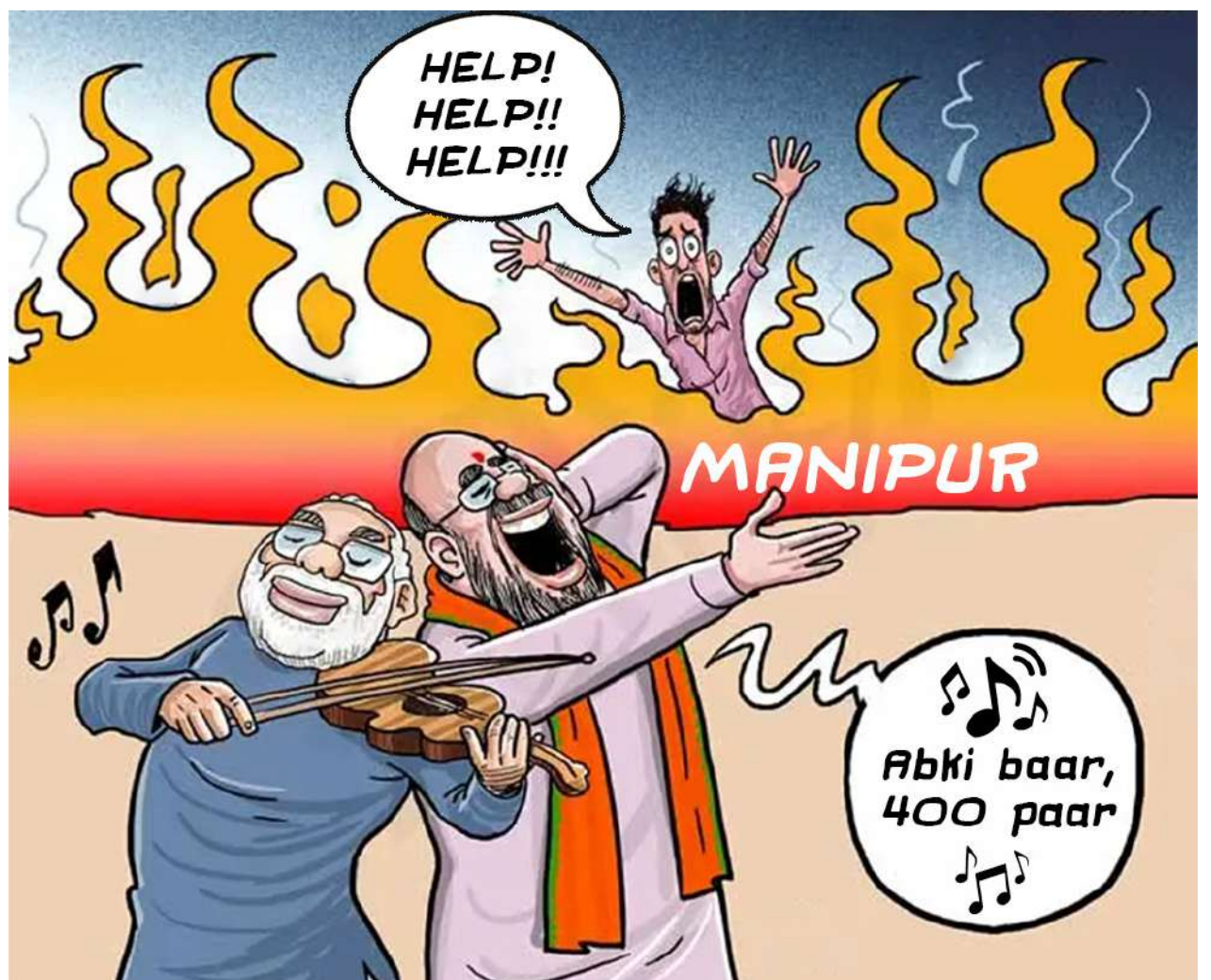
