

MANIPUR GOVT'S ATTEMPT TO DESTROY KUKI LIFELINE EXPOSES SINISTER CAMPAIGN IN MANIPUR: KUKI INPI CHANDEL

In a harrowing escalation of ethnic tensions in Manipur, the Kuki community accused the state government of aiding and abetting attacks against their people. Since May 3, 2023, allegations of ethnic cleansing against the Kuki people have surfaced, revealing the grim reality of violence and displacement. The destruction of vital bridges further isolated Kuki areas, prompting community-driven initiatives like the construction of the Selloitha Bridge over the Gunpi River.

The Kuki people of Chandel district, especially those residing in the foothills between Chandel and Kakching districts, have long lived harmoniously in an area that has been their home for generations, even before Manipur attained statehood in 1972. The Kuki inhabitants in the Chandel district side of the Sugnu foothills have always relied on two main bridges: the Napat bridge over the Gunpi (Imphal) river and the Serou bridge over the Chakpi river. However, the Napat bridge connecting Sugnu to Lamka was maliciously destroyed by Meiteis on May 28, 2023, further isolating the Kuki areas.

The geographical reality has left the Kuki areas of Chandel and Tengnoupal districts completely cut off from the valley and other Kuki dominated hill districts. This isolation has necessitated the construction of a bridge to connect these areas with Lamka, to ensure the proper supply of essential commodities. Recognising the dire need for connectivity, the Kuki community of Chandel district came together, pooling their limited resources to construct a bridge over the Gunpi River without any governmental or organisational assistance. They worked tirelessly with donations from Kuki people. This effort is justified under the Right to Life as guaranteed by the Constitution of India.

However, on May 25, 2024, tensions reached a boiling point as Meitei militants, purportedly in Manipur Police uniforms, attempted to destroy the under-construction Selloitha Bridge. The Kuki Inpi Chandel, representing the Kuki community, condemned these attacks as

The ethnic cleansing against Kuki-Zo people, which began on May 3, 2023, and continues to this day, has clearly shown that Manipur government has utterly failed to protect the rights, lives, and properties of the Kuki-Zo people. In fact, there is clear evidence that the state government has aided and abetted this genocide against the Kuki-Zo people and hence has lost its authority to enforce its biased rules in Kuki-Zo areas. The Kuki-Zo people of Chandel district, especially those residing in the foothills between Chandel and Kakching districts, have long lived harmoniously in the area that has been their home for generations, even before India's independence in 1947. The Kuki-Zo inhabitants in Chandel district side of the Sugnu foothills have always relied on two main bridges: Napat Bridge over the Gunpi (Imphal) River and Serou Bridge over the Chakpi River. However, the Napat Bridge connecting Sugnu to Lamka was maliciously destroyed by Meiteis on May 28, 2023, further isolating the Kuki-Zo areas.

This isolation necessitated the construction of a bridge to connect these areas with Lamka, ensuring essential supplies. Recognizing the dire need for connectivity, the Kuki-Zo public of Chandel district came together, pooling their limited resources to construct a bridge over the Gunpi River without any governmental or organizational assistance. They worked tirelessly with donations from Kuki-Zo people. This effort is justified under the Right to Life as guaranteed by the Constitution of India.

Today, May 25, 2024, Meitei militants in Manipur Police uniforms, accompanied by state-sponsored Meitei terrorists, attempted to violate Kuki-Zo areas and embarked on a mission to destroy the under-construction bridge. This blatant attempt to undermine the survival of the Kuki-Zo people is both unacceptable and unlawful. The Meitei government, unable to tolerate the Kuki-Zo's capability to construct such a vital bridge, views this project as a threat to their agenda of isolating and annihilating Kuki-Zo tribals in these regions.

The Kuki Inpi Chandel demands to know why Central Security forces have allowed state-sponsored Meitei terrorists in police uniforms to roam freely in Kuki-Zo areas while Kuki-Zo tribals are restricted and confined to their villages. This biased enforcement of law and order to crush the Kuki-Zo tribal minorities is unacceptable and will not be tolerated. Kuki Inpi Chandel vehemently condemns this blatant attempt by radicalized Manipur Police along with Meitei insurgents and terrorists to intrude into Kuki-Zo territory on May 25, 2024, to destroy the Selloitha Bridge, which is currently under construction. The Kuki-Zo people hereby warn that any further attempts to intrude into Kuki-Zo areas by Meiteis or anyone representing the Government of Manipur will be met with severe consequences. The Kuki-Zo tribals will not tolerate this infringement on their right to life by the biased Manipur government and will resist tooth and nail against any attempts to deny us our right to life.

The Kuki Inpi Chandel shall not be responsible for any consequences arising from the Meitei-centric Government of Manipur and the Meitei state police forces' attempts to deny our right to existence if they persist in their agenda to destroy our vital bridge.

THREAT LETTER ISSUED TO MANIPUR CCF, BOMB PLANTED IN HIS RESIDENCE

The Chief Conservator Forest Department of Manipur Longjam Joykumar was threatened with a bomb by an underground outfit on Saturday.

The explosive device was found along with a letter written as "The last warning," reportedly served by the proscribed Kangleipak Communist Party — Noyol group.

This was confirmed when a team of Manipur police rushed to the residence of Longjam Joykumar, 58, the Chief Conservator Forest, Manipur, located at Wangoi Longjam Leikai under the Wangoi Police station in Imphal West district at around 10 AM on Saturday.

Upon receiving a WhatsApp message, a team of the Manipur police bomb detection and disposal squad quickly responded and identified the object as a hand grenade placed in the courtyard of the Chief Conservator.

Near the bomb, there was a letter stating "The last warning Sir, Joykumar, Chief Conservator of

The bomb experts successfully removed the explosive device, the police said, adding that monetary demand may be the cause of the case. A case in this regard was registered, the police added.



A NAGA DOCTOR FACED DEATH THREAT FROM MANIPUR POLICE; ALL NAGA DOCTORS' FORUM MANIPUR CONDEMNS POLICE ACTION

In the lawless state of the Meiteis' Kangleipak in the erlstwhile state of Manipur, the minority communities have faced existential threat of their lives and properties. Not only the Kukis who are devastated in the hands of the communal Meiteis under the incumbent fascist regime of N. Biren Singh, the other minority communities such as the Manipur-Naga and Muslims have also been targeted every now and then.

In a serious incident of crime involving the law enforcing agency, the Manipur Police man-handled a Doctor belonging to the Naga community and attempted to murder him without any plausible reason. On the 24th of May, 2024 at around 9:00 PM, a medical officer, Dr. Larung Mejonah, currently posted at Moreh Hospital, Tengnoupal District, was manhandled and detained for hours by the Manipur Police in the heart of Imphal city, at Konung Mamang, Imphal. The police personnel also threatened to murder him.

Strongly condemning the incident, the All Naga Doctors' Forum, Manipur (ANDFM) has demanded the concerned authority to book the Manipur Police personnel involved in the incident and to suspend and relieve such individuals from their duty.

In a statement issued on Saturday, the Doctors' Forum has said that about 6-7 personnel of Manipur Police stopped the Medical Officer, Dr. Larung Mejonah, at Konung Mamang at around 9 PM and asked for car documents which were produced promptly. When he told the police that he was a doctor, currently posted in Moreh Hospital as Medical Officer, Manipur Health Services, the police replied "adudi hatpabu yarene (in Meitei dialect)", which means "Then, you can be killed (in English)". The police personnel manhandled and detained him for an hour.

MAINLAND INDIAN WORKING AT PLY FACTORY SHOT ON LEG IN MANIPUR

A 40 year old non-local was shot on his left side leg by unknown miscreants at Thokchom Louyai under Yairipok Police station on Saturday. Reason(s) behind the shooting remains to be confirmed.

As per police sources, the incident took place at around 4:40 PM. The victim has been identified as Sayeed Farooque Zamal, son of Aksar Ali from Gosaigao Athbari, Assam. He served as a manager at PBS Ply factory located at Wangjing Sabal leikai under Khongjom Police Station, Thoubal district.

According to sources, the victim was kidnapped by unknown armed miscreants along with one Meitei woman on the midnight of friday. The woman was also staying at the factory as a labourer and she was identified as Nungsithoi, a resident of Keirak, Kakching District. Whereabouts of the woman and reason(s) behind their kidnap remains unknown till the filing of this report.




A case has been registered at Yairipok Police Station for further investigations and the victim was hospitalized at Raj Medicity after being given first aid treatment at Thoubal district hospital.

ORANGE ALERT FOR HEAVY RAIN IN NORTHEAST ON MAY 27 OWING TO CYCLONE REMAL

The India Meteorological Department (IMD) has said that a cyclonic storm developing in the Bay of Bengal is likely to reach near the coasts of West Bengal and adjoining Bangladesh on Sunday (May 26) as a severe cyclonic storm.

In anticipation of inclement weather conditions, the IMD has forecasted squally weather conditions spreading to adjoining areas of the North Bay of Bengal, with galeforce winds reaching speeds of 60-70 kmph, gusting up to 80 kmph from the morning of May 25.

IMD has further issued an orange alert for the states of Arunachal Pradesh, Assam, Meghalaya, Nagaland, Manipur, Mizoram, and Tripura in the Northeast, warning of heavy to very heavy rainfall at isolated places as a consequence of the cyclone's trajectory.



The weather department has also issued a warning for the fishermen and said, "They are advised not to venture into the south Bay of Bengal till 24th May, central Bay of Bengal till 26th May and North Bay of Bengal from 24th May onwards till the morning of 27th May. Fishermen out at sea are advised to return to the coast."

Ethnic clashes in India's Manipur state saw its most ESU coach Ngampao Kipgen, a member of the Kuki successful women's club fail to field a team in the tribe, told Reuters he was forced to flee to the hills Indian Women's League in 2023-24, with its coach fleeing his burning home and a number of players in self-imposed exile interstate.

The unrest in the northeastern state, which has resulted in more than 200 dead and tens of thousands displaced, divided football teams like Eastern Sporting Union (ESU) along ethnic lines and forced some players out of the state.

"At first we didn't think it would be that bad, but ESU manager Homendro Irengbam said the suddenly it was everywhere," former ESU skipper Irom Prameshwori Devi, who has since joined East Bengal, told Reuters of the outbreak of violence.

"We had five Kuki players in the team ... they were scared because Kukis were being attacked on the streets of Imphal. We were trying to assure them it would be fine, but houses were being burned by then."

Violence erupted in Manipur on May 3, 2023 between the majority Meitei and minority Kuki communities over the potential sharing of economic benefits and but finished fourth in the group stage before quotas in government jobs and education.

As warring groups set fire to each other's homes and inaugural 2016-17 season. places of worship, football teams in the capital Imphal also found themselves splintered.

with his family after his house was burned down.

"They came in the middle of the night. I had to leave with my wife and children," Ngampao said. "I have no team here, no income. I am helpless."

According to official figures released in February, Ngampao's house was one of more than 13,000 structures destroyed during the violence.

conflict, which broke out while the team was playing in the IWL in the western state of Gujarat, drove a wedge between players.

"Our Kuki players were staying with Meitei roommates but once the conflict started, they wanted to stick together," he said. "Match preparation, team meetings, everything was disturbed. That was reflected on the field."

The team tried to put on a united front, Devi said, crashing out in the semi-finals of the 2022-23 competition, a contest they had won in the

When the tournament ended, the manager urged his players not to return to Manipur.

"I told them, 'If you go back, you'll become village defence volunteers. You'll stop playing football and join the war'," Irengbam said.

While most ESU first team players were signed by clubs around India, many Manipuri players did not escape the fighting.

"Some players have joined volunteer units. They have taken up arms. It's a miserable situation," ESU coach Ngampao said.

Today, Manipur remains divided with Meiteis controlling the Imphal valley, which includes the state capital and most of the sporting infrastructure.

The Kukis are in surrounding hills with the two sides separated by a stretch of no-man's land monitored by federal paramilitary forces.

Manipur has been a hotbed of Indian sport, sending a stream of athletes to the Olympics and other international competitions.

The state women's team has won 22 of 28 national soccer championships, claiming their most recent title earlier this month, but without any Kuki players.

Six players from Manipur, none of whom are Kukis, are in the women's national team, which is ranked 55

places above the men and represents India's best hope of World Cup qualification.

But ESU can no longer afford to play in the national Indian Women's League after community contributions dried up due to the conflict. "Unfortunately, we were not able to even pay some of the players," Irengbam said.

Midfielder Lhingneilam Kipgen, one of ESU's Kuki players, said she had not returned to Manipur due to the violence and joined Delhi-based Garwhal United, but still missed her old club.

"I hope ESU come back. When things are better I want to join again," she said.

The unrest also prevented Kuki players reporting for pre-season training for Imphal-based NEROCA and TRAU, the two biggest men's soccer teams in the state. Both teams have since been relegated from India's second tier after playing the 2023-24 season in exile.

"The mental trauma is still there for all the players. We are participating against all odds," TRAU general secretary Phulen Meitei said.

"Our own people are (being) killed ... football is less important than life."

The intervention from the central government is needed for humanitarian reasons. As no single Kuki can enter Imphal, road communication in the tribal area is vital.


