





CONTINUOUS 'BREACHING OF BUFFER ZONES' BY VBIGS KEY FACTOR FOR SPORADIC GUNFIGHTS SAYS KUKI-ZO TOP BODY, CONDEMNS ATTACKS IN KANGPOKPI'S KANGCHUP AREA

Barely a few days of deadly attacks launched by the Valley-Based Insurgent Groups including the surrendered UNLF-MPA, the Arambai Tenggol in Kangpokpi's Satang area and Khamenlok area, the Meitei militant groups, and the Arambai Tenggol continued their aggression by launching another horrific attack on the Kuki-Zo Village Volunteers in Kangchup area in Sadar Hills Kangpokpi this afternoon.

However, the deadly attacks failed as huge casualties were incurred by the Meitei militants and the Arambai Tenggol.

Though the exact number of dead and injured could be ascertained, it was reported that as many as seven Valley-Based Insurgent Groups comprising the surrendered UNLF-MPA and the Arambai Tenggol were killed and many others sustained critical injury.

Meanwhile, the Kuki-Zo Village Volunteers were also reported to have seized four automatic weapons including two SLRs, one LMG, and one AK from the VBIGs in the gunfights.

The situation in the region remained tense till the filing of this report.

Meanwhile, citing continuous breaching of buffer zones as the main factor for sporadic gun fights in the peripheral areas, the Kuki-Zo top body in Sadar Hills Kangpokpi District, the Committee on Tribal Unity, or the CoTU, Sadar Hills strongly accused the valley-based armed miscreants of creating unrest by attacking the Kuki-Zo dominated areas crossing the buffer zones.

It also condemned the alleged aggression and attacks on the Kuki-Zo-dominated area allegedly by the Valley-



based secessionists including Arambai Tenggol today in the Kangchup area under Sadar Hills Kangpokpi District.

CoTU wondered as to how these armed miscreants could cross all the central security forces by breaching the buffer zones and launching an extensive attack on the Kuki-Zo volunteers who are guarding and defending the villages.

It alleged that well-armed valley-based insurgent groups breached the buffer zone and sneaked into Nakhojang village in the Leimakhong Kangchup area and launched a deadly attack on the Kuki-Zo volunteers in the afternoon.

The committee also clarified that there was no beheading of any individuals as reported by some fake, and unethical Valley-based media.

CoTU opined that it is time for the delusional Manipur Government to instruct the valley-based secessionists including ArambaiTenggol to respect the "buffer zones" for a semblance of peace within our respective areas.





JOINT BODY OF MIZORAM UNIV CONDEMNS 'TERROR FUNDING ACT', MUSU WARNS MZP OF 'SEVERE CONSEQUENCES'

Meanwhile different associations under Mizoram University have issued a joint statement in condemnation of research scholars from the university being involved in collecting and handing over funds to the Arambai Tenggol.

In a joint statement issued on January 30, Mizoram University Students' Council, Mizoram University Research Scholars' Association, Mizoram University Alumni Association, Mizoram University Teachers' Associations, Mizoram University Non- Teaching Employees Association stated that they condemned an unethical act by a student of a higher educational institution that may instigate unwanted communal tension inside the university campus and call that such unwanted incidence do not reoccur.

The joint body stated that they have taken steps to maintain peace and harmony among the different communities and ethnic groups in Mizoram University since the beginning of violence inside Manipur University campus on May 3, 2023 by issuing a joint press statement on May 4, 2023 and organizing a peace gathering on July 27, 2023 inside Mizoram University campus. "However, despite our best efforts, we are deeply aggrieved to learn that Ms. Teresa Ningthoujam, Ph.D Scholar, Department of HAMP, Mizoram University was seen involved in giving donations to the Arambai Tenggol on social media, thereby threatening the peaceful co-existence of different tribal ethnic groups inside Mizoram University campus," the joint body stated.

The joint body stated that they will strive to continue to ensure peace in Mizoram University campus and also appeal that it also prevails in all educational institutions across the nation.

Meanwhile, Manipur University Students Union has warned of adjacent consequences possibly far more



severe than expectations if the Mizoram University authority successfully happens to terminate the Ph.D programme of Teresa Ningthoujam from Mizoram University.

MUSU issued a press release in response to the Mizo Zirlai Pawl's demand for the termination of Ph.D programme of Teresa Ningthoujam from Mizoram University. MUSU stated that, "Following the demand of MZP if the Mizoram University Authority successively happens to terminate the Ph.D. programme of Teresa Ningthoujam from Mizoram University, Manipur University Students' Union vitally rings the harness bell for the adjacent consequences which could possibly far more severe than expectations".

MUSU draws the attention of all stakeholders especially those who are in academic pursuits including Mizo Zirlai Pawl and the authority of Mizoram University to refrain from irrational acts targeting academic institutions.

The very still and calmness which has been maintained by MUSU till date is purposely imperative to uphold the values of peace, respect for human life and academic excellence of Manipur University stands for, stated release.



LEE FAITH SCHOOL IN PAITE VENG, IMPHAL TURNED INTO MEITEI RADICAL GROUP'S OFFICE

A nascent Meitei extremist group, the Arambai Tenggol, has emerged as the driving force behind the militarization of Manipur state. Recently they have taken charge of Meitei people's affairs in Imphal valley and disturbingly they have besieged a school called LEE FAITH ACADEMY in Paite Veng, Imphal which belongs to the Kuki-Zo community. This heinous act has tarnished the sacredness of the school, despite schools being revered globally as temples of knowledge, where utmost respect is given.

The Meitei people, particularly the Arambai Tenggol, have chosen unoccupied schools as venues to perpetrate their acts of cruelty. Their disregard for education is evident not only in the misuse of the Lee Faith School but also in the burning down of numerous schools belonging to the Kuki-Zo community. NAGA YOUTHS DENOUNCE DESECRATION OF CHRISTIAN CHURCH BY MEITEI RADICALS

The Manipur Naga Youth Organization (MNYO) strongly condemned the desecration of Govajang church, labeling it as sacrilegious and offensive to the Christian community.

"Words are not enough to express our condemnation and disapproval of this violation. Even during times of war, places of worship are typically respected and left untouched because they are considered sacred. It is extremely unfortunate to witness volunteers from the valley mocking a church and holding the Bible, a holy book for Christians. This behavior is deeply saddening, causing distress within the Christian community, potentially fostering grievances among Christians and non-Christians," said TP. Dining, General Secretary of MNYO.

The statement highlighted that the incident at Govajang church, which has been widely circulated through a viral video, demonstrates the destruction and mockery that took place within the sacred premises. This constitutes a clear violation of the fundamental principles of religious freedom and coexistence.

Manipur, known for its diverse population, is home to a significant Christian community within the Meitei community. Such actions not only pose a threat to the social fabric but also undermine the region's long-standing tradition of harmonious coexistence, the statement emphasized.

It further stated that the wanton destruction of religious institutions, regardless of the faith they represent, cannot be justified. These actions only deepen existing divisions and cause profound harm to the community.

Certainly, the Meiteis exhibited a complete disregard for decency by engaging in a disrespectful act within the church. They staged a mock marriage ceremony using the Bible and went on to mock and taunt portraits of Jesus Christ hanging inside the church. Additionally, they shared a glass of wine, utilizing the church's chalice.





The amount of Human Rights violation in Manipur is a direct consequence of the ethnic bigotry of the Biren Singh government against the Kuki community; leading to a state-sponsored and preplanned ethnic cleansing against the Kukis. The idea of "undivided manipur" has been shattered and the only way forward now is a Separate Administration for the Kukis and the meiteis. NAGA COMMUNITY FACES RENEWED ATROCITIES FROM MEITEIS

In a renewed atrocity against the Naga community, one Tamreingam Shithung (19), a Tangkhul Naga was kidnapped by Meitei miscreants on January 29.

Condemning the kidnapping, the Zingsho Katamnao Long, an apex organisation of the Eastern Tangkhul said Tamreingam Shithung was a student of 2nd Semester, Geography Department of Liberal College, Luwangsangbam, Koirengei.

In a strongly worded press release issued on Tuesday, ZKL stated it has taken a serious exception to the kidnapping episode elucidating that Tamreingam is a bonafide resident of Bungpa Khullen village, Kamjong Sub-Division, Kamjong District, Manipur and presently residing at Dewlahland, Imphal.

ZKL stated that "Tamreingam Shithung, while on his way along with his friend to apply for scholarship, was abducted by two unidentified miscreants in Olive Green uniform and dragged into an A-Star car.

The incident happened at around 12 noon on January 29, 2024, Monday near the Pukhri, Mother Teresa Charity Home, Mantripukhri. He was safely rescued by a team of Police at about 9 pm yesterday."

The Tangkhul Students' body further said, "In times of volatile ethnic violence raging the State of Manipur since last year, the kidnapping of innocent student and demanding a ransom, which is totally uncalled for, can further ignite unnecessary tension and flare-up between the peaceful communities. Therefore, the incident as such deserves a condemnation from all sections of the communities."

The ZKL warned that it will be constrained to take stringent action in case such incident is repeated in the future.

This marks yet another instance where a Naga community has faced the brutalities inflicted by the Meitei



population, continuing a trend since the eruption of violence in Manipur on May 3, 2023. Despite considering themselves 'neutral' in the conflict between the two communities, Naga groups have borne the brunt of Meitei aggression, experiencing threats, assaults, kidnappings, and even murders at the hands of the majority community. The vulnerability of Nagas extends beyond the Kukis, encompassing the Imphal valley as well.

Instances of Meitei brutality against the Naga community include an attack on four Tangkhul women from Ukhrul district on May 24, 2023, at Airport Road in Imphal. On July 15, 2023, a Maring lady was fatally shot near the foothills of Keibi Heikak Mapal village in Imphal East district. Furthermore, on December 3, 2023, three Tangkhul men were violently assaulted at Sawombung, Imphal.

Additional incidents involve the beating of two Rongmei women at the Community hall in Bishnupur Bazaar on December 8, 2023, and the assault of a member of the Taxi Owners Association in Tamenglong with an iron rod on December 10, 2023, in Khumbong, Imphal, sparked by a dispute over money collection from a passenger vehicle.





They go to bed with empty stomachs, till the land in the scorching temperature and freezing winter, rain is not an excuse for them either - with half-full stomachs, but they work and work just so their children get an education they can't afford. The gruesome and difficult lives of at least 80% Kuki parents can be summed up with these few lines.

As children, the advice the Kuki children got the most from their parents is "Lekha ha sim a nasim ding nalet teng officer nahiding katehset phatle nop tah a nei koi ding chu o" a translation of which is "you must study hard while I am strong and can afford your education to become an officer and you must let me live a life without worries (of food and a home to sleep) when I get old." Most Kuki children will have memories of being whipped by a stick at least twice or thrice by their parents either because they were too lazy to go to school or to study, for they believe education is the only way their children can alleviate their social status and financial status and they should lead a better life than they do.

Since the 1980's and 1990's, as the exposure to education among Kuki younger parents then increases, believing education can change the future of their children which they can't afford, they shed blood, tears and sweat and be a slave if necessary, to ensure that they provided their children an education they couldn't afford, although the level they could provide was incomparable to those in big towns and cities. The tradition that they started is further continued by their children to their grand-children. Today, you might

see a number of flying colours from members of the Kuki society in UPSC or CGL or under state services, the hidden secret is the faith and belief of their parents in Education, and they ensure the efforts necessary to become one is given by their children. 12th Fail movie which is an inspirational movie for many today is the lives of many Kukis yesterday and today as well.

The arson of schools in Moreh by Manipur police commandos and the exodus of thousands from their homes both in Imphal and Kuki villages due to atrocities and attacks on their villages by Arambai Tenggols with the support of Manipur police and its commandos murdered the dreams and hope of not only thousands of children but of their parents as well. Kukis in Imphal are victims too but the more vulnerable victims are those in villages. The pogrom executed while parents tilled their lands for food and fees of their children and the innocent children while they are busy playing with their friends has vanquished everything for them along with their hopes and dreams. The right to Education under Article 21A burned along as well.

The attacks on educational institution is rather cruel and inhumane. What wrongs have the children done to be punished? Why, when every child has the right to dream, why are their dreams cut off? What offences have they done to be subjected to such cruelty?

Are the perpetrators even human? And what is the law enforcement agency who despite the evidence letting them still free? India has to a lot to reflect on the issue.

Acknowledging the importance of educational institutions and facilities, they are protected under International humanitarian law and International Human Rights law, as civilian objects and right to education respectively even in times of war. Attacks on educational buildings that are not military objectives are on the list of war crimes of 'the Rome statute of the international court' during both international and internal armed conflicts.

The institutions of police are equated with law and order. What if you witness members of this institution itself committing atrocities against you, your family and your villages? Will you still put your faith in the law and order of the state and the government? One might be poor but ain't fool enough to realize whom the police work for. To add on the tragedy, not only your home, peace, hope and dreams are shattered and burnt, but the door to justice itself is blocked for the Kukis. To rub salt on their wounds, the central government itself listens more to the government that causes their misery than your injustice. A powerful man's lie is weighted more than thousands of the poor victims.

The judiciary surrendered itself to a mob, and judgements in Manipur are pronounced taking into account the likes and dislikes of Meitei mobs who are controlled by state sponsored militia Arambai Tenggol. When needed, for their safety the judiciary even has to unsee the crimes committed at their doorstep.


The surrender of MLAs and MPs from the state could not surprise them any longer, as a firsthand victim of the atrocities and the silence of the government, they knew long before it was officially done at Kangla Fort of their collaboration. You might think things could not get worse than this, but hold on, amidst all the injustice they are living with, they are further defamed both by the government and their oppressor to whitewash their crimes. Born as Indian but called an illegal immigrant, worked honestly under the extreme weather all round year but called poppy planters, the crime by a few others are made theirs too, innocently they were living worrying about only food, clothes and tuition fees, but made a Narco-terrorist. Thus the question that awakens them at night is what freedom were their forefathers fighting for both against the British and under Netaji Subhas Chandra Bose INA? Democracy or Oppression?

They are a part of the web of the pogrom to annihilate Kukis and their history in Manipur. Their tone of their language is the evidence. When questions like - with no door left to knock at, where do they go? How long can they sustain? How long they will be unheard? Will they die along with the injustice? - bothers their head non-stop. A beacon of hope in the form of a picture has surfaced. A school principal can be seen teaching a group of female students in the same place where the state police commando arsoned their dreams and hopes along with their schools in Moreh.

Thus, as always education will be their new hope to change their life. However, the question is who will provide them with education? With the ongoing discrimination of Kukis even in education by the education department in the state, will their children benefit from it like others do? When violation of Kukis' fundamental rights and other constitution rights is then the new law of the land in Manipur as all organs of the state turns a blind eye to the crimes of their oppressor, and when the state who should be the enabler of their rights is the one who violates it, why is the central government still putting them under the government that pledges to fulfill the demands of the Taliban-like militia Arambai Tenggol whose demands not only suppress the Kukis of their right but questions the legality of their citizenship. Thus, they are back again to the question they questioned themselves over and over again is - What freedom was their forefathers fighting for?
